To Counsel for Inyo Networks, Inc. and Others on the Service List in R.23-04-006:

On June 10, 2024, Inyo Networks, Inc. (Inyo) sent an e-mail request to be excused from any noticing obligations pursuant to my May 31, 2024 Ruling setting public participation hearings (PPH) and identifying noticing obligations for holders of state-issued video service franchises. Inyo was identified in my May 31, 2024 Ruling as a video service franchisee subject to the ruling.

The basis for Inyo's June 10, 2024 e-mail request to be excused from noticing obligations set forth in my May 31, 2024, Ruling is that on April 18, 2024, Inyo submitted a notice of termination of its state-issued video franchise to the California Public Utilities Commission (Commission).

Based on these facts, Inyo is excused from the noticing requirements set forth in my May 31, 2024, Ruling. This ruling will be issued in three batches.
