3. **Fire sprinkler rate:** A single-family residence with a meter size that has a “fire sprinkler” rate (listed above) is eligible for that rate if: (a) the customer is paying for service where a residential fire sprinkler system is required/requested to be installed by local fire or building codes; (b) a smaller meter would be large enough to provide adequate service in the absence of the additional demand needed to supply water to the system; (c) the sprinkler system is served through the meter providing residential water service; and (d) the customer requests the “fire sprinkler” rate. The Company may seek verification that the above criteria are met. This service will be considered a general metered service, and not a fire service, so the rules and conditions for general metered service shall apply.

- f. The sum of the current and all prior monthly entries in 3.e., above;
- g. The sum of the current and all prior monthly entries in 3.d., above;
- h. The sum of 3.f. and 3.g.

Eighty-five percent (85%) of the reasonable cost difference will be flowed through to customers, and fifteen (15%) of the reasonable cost difference will be at the company's risk. 5. APPLICABILITY

The HCBA6 is effective beginning January 1, 2026, through December 31, 2028, and applies to all ratemaking areas ("districts") and Customer Support Services (General Office). This excludes out-of-state affiliates and unregulated operations expenses.

6. ACCOUNTING PROCEDURE:

There is no rate component to the HCBA6. Cal Water shall record for future disposition the following entries:

- a. Eighty-five percent (85%) of the difference between the adopted health care expenses and the actual cost incurred as health care expenses will be included in the balancing account, as either a debit or a credit balance depending upon if the actual costs exceed or are less than the amounts adopted in rates. The capitalized portion of health care expenses at the adopted capitalization ratio will be excluded.
- b. A monthly debit or credit entry equal to the average balance in each segment of the account multiplied by 1/12th of the most recent month's interest rate on Commercial Paper (prime, 90-day) published in the Federal Reserve Statistical Release H-15.

7. DISPOSITION:

The HCBA6 is recoverable or refundable in a Tier 2 advice letter filing in accordance with General Order 96-B and standard practices or by request in the next general rate case.

**XX. Contaminant Remediation Memorandum Account (CREMA)**

(N)

1. PURPOSE

The purpose of the CREMA is to record all incremental costs to comply with any new or revised Federal Environmental Protection Agency and/or California’s State Water Resources Control Board, Division of Drinking Water rules, including, but not limited to, Maximum Contamination Levels (MCL) and contamination remediation requirements.

The CREMA shall track incremental expenses related to capital, operation and maintenance, administration and general, monitoring, legal, and consultant expenses associated with activities to mitigate the effects of any new or changed rule or contaminant level.

2. APPLICABILITY

The CREMA does not have a rate component. Cal Water shall maintain the CREMA by making entries at as follows:

- a. A debit entry shall be made to the CRMA to record incremental costs.
- b. Interest shall accrue on a monthly basis by applying a rate equal to one-twelfth of the rate on three month Commercial Paper Rates, as reported in the Federal Reserve Statistical Release, H.15 or its successor.

3. DISPOSITION

Cost recovery shall be net of any previous expenses that were authorized to comply with previous remediation requirements that have been superseded as well as any reimbursements directly related to the projects and costs being accumulated in the CREMA.

1. Purpose

The purpose of the SIBA and SCBA is to record: 1) the difference between Cal Water’s adopted SIBA-eligible revenues and actual SIBA-eligible revenues; and 2) the difference between adopted water production expense and actual water production expense, respectively. The SIBA/SCBA is intended to fully decouple water revenue from sales to support the co-equal beneficial affordability and conservation while providing a reasonable opportunity to timely recover authorized revenue requirements. The SIBA/SCBA is established in accordance with XXXX.

2. Applicability

The SIBA/SCBA applies to all areas served by Cal Water.

3. Definitions

- a) **Non-SIBA revenue** is all revenue excluded from the SIBA, including metered service charges, raw water quantity charges, public and private fire service, flat rate residential service, and other unmetered miscellaneous revenue. Surcharges and surcredits, unless specifically included in the adopted revenue requirement, are excluded from SIBA/SCBA accounting.
- b) **SIBA-eligible revenue** is all revenue not included in item 3.a, above. Generally, SIBA-eligible revenue results from quantity charges for residential and non-residential customers, including quantity charges to recycled water customers.
- c) **Adopted SIBA-eligible revenue** is the amount of revenues related to item 3.b authorized by the California Public Utilities Commission (“Commission”) or Water Division for the relevant period.
- d) **Actual SIBA-eligible revenue** is the amount of revenues related to item 3.b billed to customers during the relevant period.
- e) **SIBA revenue** is the difference between adopted SIBA-eligible revenues and actual SIBA-eligible revenue
- f) **SCBA-eligible expense** is all water production expense, including purchased water, purchased power, and groundwater charges (i.e., pump taxes).
- g) **Non-SCBA-eligible expense** is all expense not included from item 3.f, above.

- h) **Adopted SCBA-eligible expense** is the amount of water production expense related to item 3.f authorized by the California Public Utilities Commission (“Commission”) or Water Division for the relevant period.
- i) **Actual SCBA-eligible expense** is the amount of all SCBA-eligible expense incurred during the relevant period.
- j) **SCBA expense** is the variance between adopted SCBA-eligible expense and actual SCBA-eligible expense.

4. Accounting Procedures

- a) The following entries will be recorded monthly to each district’s SIBA:
  - 1) Adopted SIBA-eligible revenue
  - 2) Actual SIBA-eligible revenue
  - 3) Net SIBA revenue balance = (1) minus (2)
- b) The following entries will be recorded monthly to each district’s SCBA:
  - 1) Adopted SCBA-eligible expense
  - 2) Actual SCBA-eligible expense
  - 3) Net SCBA expense balance = (2) minus (1)
- c) Total Net SIBA/SCBA balance = Net SIBA revenue plus Net SCBA expense
- d) Cal Water will record the accumulated SIBA/SCBA balance monthly by adding the monthly balances in sections 4.a.3 and 4.b.3 to the prior month’s accumulated balance.
- e) Cal Water will accrue interest monthly by applying one-twelfth of the most recent three-month Commercial Paper rate – nonfinancial, from the Federal Reserve’s Statistical Release H.15 (or its successor) to the average net accumulated SIBA/SCBA balance. Accumulated interest will be included in the amount upon which interest is charged but will be identified as a separate component of the SIBA/SCBA accounts.

5. Disposition / Rate Adjustments

- a) By November 30<sup>th</sup> of each year, Cal Water will submit a Tier 1 advice letter providing report on the status of the SIBA/SCBA and requested rate change to recover or refund, as appropriate, the total Net SIBA/SCBA balance. The Tier 1 advice letter will include a section on the total net SIBA/SCBA balance in each rate area for the period of October 1<sup>st</sup> of the previous year through September 30<sup>th</sup> of the current year.
- b) The Tier 1 advice letter will also include the net total Net SIBA/SCBA balance for recovery or refund during the upcoming period. The total Net SIBA/SCBA balance will be collected from or returned to eligible customers by including the total Net SIBA/SCBA balance in quantity rate levels along with Cal Water’s authorized base quantity revenue requirement for the upcoming period and recovered via the adopted rate design by rate area. The total Net SIBA/SCBA balance will be reflected in January 1<sup>st</sup> rate levels designed to recover the balance over a 12-month period. The Net SIBA/SCBA balance may need to be adjusted to align the 12-month recovery period beginning on January 1<sup>st</sup> of a given year. Any unamortized balance from a prior period will automatically rollover as the beginning balance for the subsequent period.

6. Adopted Quantities

In order to properly record and report on the SIBA/SCBA balance, Cal Water proposes this preliminary statement as a central location to memorialize the adopted quantities for SIBA-eligible revenue and SCBA-eligible expense. The adopted quantities will be allocated across the 12-month period using a revenue curve based on a three-year average usage distribution. Any time Cal Water files a rate change or other advice letter affecting these components, it will file to amend the appropriate section of the adopted quantities in this preliminary statement.

7. Effective Date

The RSF Program is funded through surcharges on other customers as specified below.

**I. RSF SURCHARGE**
