Subject: A.24-05-0007 (SCE 2025 ERRA Application) Email ruling acknowledging reduced comment and reply period and directing protesting parties to respond.

Parties and Service List to Application 24-05-007:

The Joint Party Prehearing Conference Statement, filed by Southern California Edison Company on behalf of itself and California Community Choice Association, the Direct Access Customer Coalition, and the Public Advocates Office at the California Public Utilities Commission on July 24, 2024, contained a

proposed schedule that was stipulated to by all parties to this proceeding. This proposed schedule provided parties seven days to file opening comments on the proposed decision (PD) and a further seven days for parties to file reply comments. Based upon this, I find that parties have stipulated to a reduced opening and reply comment period on the PD of seven days for opening comments and a further seven days for reply comments.

Parties are directed to indicate in a filed response to this ruling no later than September 25, 2024. If they do not stipulate to this reduction in time for opening and reply comments on the PD, failure to timely respond to this motion will result a waiver by the party of the right to object to the interpretation of the stipulated schedule outlined in this ruling.
