Subject: Administrative Law Judge's Email Ruling Granting Party Status (A.24-05-009)

To Parties in A.24-05-009:

This email ruling grants the motion for party status of the Alliance for Retail Energy Markets (AReM), which AReM filed in this docket on October 28, 2024.

Rule 1.4 addresses participation in Commission proceedings. Pursuant to Rule 1.4 (b), a person seeking party status by motion shall “(1) fully disclose the persons or entities in whose behalf the filing, appearance or motion is made, and the interest of such persons or entities in the proceeding; and (2) state the factual and legal contentions that the person intends to make and show that the contentions will be reasonably pertinent to the issues already presented.” Rule 1.4 (c) states that the assigned Administrative Law Judge may, where circumstances warrant, deny party status or limit the degree to which a party may participate in the proceeding.

The October 28, 2024 motion of AReM meets the requirements of Rule 1.4 (b).

Therefore, IT IS RULED, the motion is granted and AReM is granted party status.
