3. Description of Services to be Provided [Rule 3.1(e)]

The applicant must clearly describe its operation including but not limited to identifying the authority that it is seeking. The applicant should clearly identify the type of service it proposes to provide. It could be any of the following combination of service types: Resold or Limited Facilities-Based Local Exchange or Interexchange service. The applicant should provide information regarding the service areas it plans to provide service to and the method by which it plans to provide the service.

Sequoia Wireless is seeking authority to operate as a competitive local exchange and interexchange carrier in order to provide resale and limited facilities-based competitive local exchange service in the service territories of Pacific Bell Telephone Company d/b/a AT&T California (AT&T California), Frontier California Inc. (Frontier California), Citizens Telecommunications Company of California, Inc. d/b/ a Frontier Communications of California (Frontier Communications), and Consolidated Communications of California Company (Consolidated Communications, formerly SureWest Telephone), and resold interexchange services throughout California.

Sequoia Wireless will construct the interconnect side of a modern IP telephone central office in each LATA where service is to be provided. These facilities will consist of an IP media gateway to translate TDM formatted, SS7, or MF signaled trunks to SIP signaled IP-based call traffic, in addition to the physical hardware to terminate and connect any T1, T3, or OC-X circuits that will be obtained from interconnection partners (Add-drop mux, DSX bay). This equipment will be installed alongside battery backup and monitoring systems to ensure high availability and reliability. These systems will feed into an IP-based soft switch to provide customers with dial tone and call routing services. Finally, a 4G/5G core network and IMS core will be deployed to handle device-side connectivity from end-user devices and other carriers' mobile core networks. This equipment will terminate IP format connections from the end user's mobile handsets.

This equipment will be used to provide local exchange telephone service to Sequoia Wireless's cellular subscribers by utilizing T-Mobile's network, which is obtained through a connection with PWG as the local loop part of the connection. Subscriber's devices' IMS network parameters will either point directly to Sequoia's IMS core network for voice services or pass through T-Mobile/PWG's P-CSCF before reaching Sequoia's S-CSCF, which will provide voice services. In this arrangement, the underlying MNO's network will only transport the voice services from users' phones to Sequoia's network, which will provide the voice-grade network services.

Once end-user traffic reaches Sequoia's facilities, Sequoia will provide all aspects of voice access to the PSTN and own the number of blocks from which Sequoia's customers will be supplied. Inbound voice traffic will travel to Sequoia's main switch, which will be routed directly to the end-user's device based on phone number. Critically, Sequoia will maintain the LERG records and interconnection with the local and feature group D tandems and carriers. Likewise, Sequoia will receive outbound calls from customer devices and route them to the appropriate trunk. Sequoia will additionally perform TDM-to-IP and SS7-to-IP conversion required to interconnect its 5G network core with the PSTN.

Sequoia Wireless will provide customers with "telephonic connection to, and a unique telephone number on," the company switching network that enables customers to "receive calls from other stations on the public switched telephone network". Sequoia Wireless is not seeking Full Facilities-Based CPCN and is not required to comply with Proponent's Environmental Assessment (PEA) and California Environmental Quality Act (CEQA) Rule 2.4 of the Commission's Rules of Practice and Procedure.

4. Articles of Organization & Certificate of Qualification to Transact Business in California [Rule 2.2]

All applicants other than natural persons shall submit with their applications a copy of the entity's organizing documents and evidence of the applicant's qualification to transact business in California. The applicant must provide a copy of its Certificate of Good Standing Status certified by the Secretary of State of California as an attachment to its application.

Copies of the organizing documents for Sequoia Wireless are under Attachment C.

Evidence of Sequoia Wireless qualification to transact business in California is shown under Attachment C, which provides a copy of its Certificate of Good Standing Status certified by the Secretary of State of California.

5. Description of Proposed Construction [Rule 3.1(a)]

The applicant must provide a full description of the proposed construction or extension, and the manner in which the same will be constructed.

Sequoia Wireless is an applicant seeking authority as a Limited Facilities-Based provider and that it does not intend to construct any facilities. The installation of telecommunications facilities will occur in existing conduit or other structures and thus would not result in material adverse impacts. It can be seen with certainty that there is no possibility that the project would have a significant adverse effect on the environment and thus the project is exempt from CEQA review; *See* D.08-04-018 and D.99-10-025.

Pursuant to 14 CCR §15301, applicant attests that as there is no intention to construct any facilities, with the project occurring in existing facilities, and thus the project involved are classified under a Class 1 Exemption to exempt from CEQA and for which neither an EIR nor a Negative Declaration is required.

6. California Environmental Quality Act (CEQA) Compliance [Rule 2.4]

Pursuant to CEQA and Commission Rule 2.4, the Commission examines projects to determine any potential environmental impacts in order that adverse effects are avoided, and environmental quality is restored or enhanced to the fullest extent possible under CEQA. In Rule 2.4(b), the Commission recognizes that the Secretary for Resources has exempted certain classes of projects from CEQA.

Sequoia Wireless is an applicant seeking authority as a Limited Facilities-Based provider and that it does not intend to construct any facilities. The installation of telecommunications facilities will occur in existing conduit or other structures and thus would not result in material adverse impacts. It can be seen with certainty that there is no possibility that the project would have a significant adverse effect on the environment and thus the project is exempt from CEQA review; *See* D.08-04-018 and D.99-10-025.

Pursuant to 14 CCR §15301, applicant attests that as there is no intention to construct any facilities, with the project occurring in existing facilities, and thus the project involved are classified under a Class 1 Exemption to exempt from CEQA and for which neither an EIR nor a Negative Declaration is required.

7. Names of Competitors and Names of Counties [Rule 3.1(b)]

The applicant must provide the names and addresses of all utilities, corporations, persons or other entities, whether publicly or privately operated, with which the proposed construction is likely to compete, and of the cities or counties within which service will be rendered in the exercise of the requested certificate. The application shall contain a certification that a copy of the application has been served upon or mailed to each such person named.

Sequoia Wireless is requesting to be granted limited facilities-based authority and will not construct any facilities other than equipment to be installed in existing buildings or structures with proposed constructions described above expected not to compete. Service is requested to be rendered in service territories of Pacific Bell Telephone Company d/b/a AT&T California (AT&T California), Frontier California Inc. (Frontier California), Citizens Telecommunications Company of California, Inc. d/b/ a Frontier Communications of California (Frontier Communications), and Consolidated Communications of California Company (Consolidated Communications, formerly SureWest Telephone) throughout California.

Pursuant to D.97-06-107, issued in Commission proceeding R.94-02-003/I.94-02-004, CLCs are no longer required to comply with Rule 18(b) and General Order 96-A, subsections (G)(1) and (2). Thus, the applicant is not required to mail its application to all potential competitors and counties. However, Sequoia Wireless, LLC will provide a copy of its Application upon request to potential competitors and counties.

8. Areas of Service (Maps) [Rule 3.1(c)]

The applicant must clearly describe and provide a map of the service territories it proposes to serve. It should also identity the entities currently providing service in the area pursuant to D.95-12-056, Appendix C, Rule 4.E. The map should be included as an attachment to the application.

Service is requested to be rendered in service territories of Pacific Bell Telephone Company d/b/a AT&T California (AT&T California), Frontier California Inc. (Frontier California), Citizens Telecommunications Company of California, Inc. d/b/ a Frontier Communications of California (Frontier Communications), and Consolidated Communications of California Company (Consolidated Communications, formerly SureWest Telephone) throughout California. Attachment J provides a copy of the proposed service area.

9. Identification of Required Franchises, Health and Safety Permits [Rule 3.1(d)]

The Applicant must provide a statement identifying the franchises and such health and safety permits as the appropriate public authorities have required or may require for the proposed construction or extension.

As an applicant seeking authority as a Limited Facilities-Based carrier, Sequoia Wireless hereby states that no franchises or health and safety permits have been required, nor are any anticipated to be required by any public authority for the proposed construction or extension of facilities. The Applicant's planned operations and infrastructure expansions will utilize existing infrastructure and public utility pathways, negating the need for new franchise agreements or additional permits.

Sequoia Wireless will continue to monitor for any regulatory changes or additional requirements that may arise but affirms that, to the best of its knowledge and under current regulations, the project meets all necessary compliance standards without additional franchise or permit obligations.

10. Facts Showing Public Convenience and Necessity [Rule 3.1(e)]

The applicant must demonstrate that granting its application will benefit the public interest.

Granting this Application aligns with the California Public Utilities Commission's (CPUC) findings that competition in the telecommunications industry serves the public interest. Previous decisions—D.95-07-054, D.95-12-056, and D.96-02-072—highlighted the benefits of competitive local exchange and intraLATA services, including technological innovation, service improvements, and economic growth. In keeping with these precedents, granting this Application will provide public interest benefits as follows:

- 1. Expansion of Technologically Advanced Telecommunications Services: Approval will enable the applicant to extend access to state-of-the-art telecommunications solutions throughout California, thereby advancing connectivity and digital inclusivity across California.
- 2. Promotion of Innovation: Increased competition will foster technological innovation by encouraging providers to continuously enhance service quality, reliability, and security.
- 3. Lower Rates and Enhanced Service Options: Competition inherently drives down prices, resulting in more affordable services for consumers. Users will also benefit from a broader selection of service packages tailored to meet diverse needs.

In light of these factors, granting this Application will directly benefit the public by enhancing telecommunications service options, affordability, and accessibility throughout the State.

11. Estimated Cost of Construction, Annual Fixed and Operating Costs and Economic Feasibility [Rule 3.1(f)]

The applicant must provide a statement detailing the estimated cost of the proposed construction or extension and the estimated annual costs, both fixed and operating associated therewith. In the case of a utility which has not yet commenced service, or which has been rendering service for less than twelve months, the applicant shall file as a part of the application supporting statements or exhibits showing that the proposed construction is in the public interest and whether it is economically feasible.

The estimated cost of the proposed construction is estimated to be \$25,000 to \$35,000 with ongoing operating costs estimated to be around \$5,000 to \$7,000. Sequoia Wireless plans to integrate with the wireless side of the business, giving a built-in customer base.

Furthermore, we would apply for an ETC designation to qualify for federal USF Lifeline funds, which if approved, would allow access to \$9.25/customer of LifeLine per month. This revenue source is significant, as more revenue would allow more resources to be available.

12. Financial Statements and Ability to Finance [Rule 3.1(g) and 2.3]

In order to be granted a CPCN, an applicant seeking authority to provide limited-facilities-based and resold local exchange and interexchange services must demonstrate that it has a minimum of \$100,000 cash or cash equivalent to meet the firm's start-up expenses. The applicant must also demonstrate that it has sufficient additional resources to cover all deposits required by local exchange carriers and/or interexchange carriers in order to provide the proposed service. The applicant must provide statements or exhibits showing the financial ability of the applicant to render the proposed service together with information regarding the manner in which applicant proposes to finance the cost of the proposed construction or extension.

Applicant demonstrates that it is financially capable of rendering its proposed service through the following:

- 1. Available balance of **\$112,132** in Sequoia Wireless Business Checking Account. Included under Attachment H is the bank statement for the month of October 2024 reflecting this available balance as of the last day of the bank statement (October 30, 2024).
- 2. Since inception, Sequoia Wireless has spent \$187,132 on operating expenses and capital expenses that include our start-up expenses. As we have already incurred the vast majority of start-up expenses, the available balance of \$112,132 coupled with our launch in December 2024 as a California LifeLine Service Provider demonstrates sufficient additional resources to cover all deposits required by local exchange carriers and/or interexchange carriers in order to provide the proposed service.
- 3. Included in Attachment G is a Profit and Loss statement for Sequoia Wireless from inception on February 4, 2023, to October 31, 2024. While this statement was not required, we felt it necessary to provide a complete financial picture. The following are key highlights:
 - a. From January 1 through October 31, Sequoia Wireless resulted with \$22,282 in Gross Profit.
 - b. In the previous month, we experienced our first profitable month with \$3,890 in net profit.
 - c. Sales this year through October 31 have totaled \$79,464.
 - d. Since inception, we have incurred direct costs of \$164,033.
- 4. Included in Attachment K is an unaudited Balance Sheet for Sequoia Wireless as of October 31, 2024.
 - a. Current assets were **\$211,895** with current liabilities amounting to **\$100,992**. Current assets are in excess of current liabilities by **\$110,903**.
 - b. Total Equity stood at **\$90,778** with Paid-in Capital to date amounting to **\$347,996** and Retained Earnings totaling (**\$257,219**).
 - c. Applicant will be able to maintain sufficient liquidity for its first year of operations.
- 5. As a supplement to the unaudited Balance Sheet for Sequoia Wireless, we included a complete list of Inventory, Supplies, Assets with a total cost of **\$90,511**.

13. Proposed Rates [Rule 3.1(h)]

The applicant must provide a statement of its proposed rates to be charged for service to be rendered. If the application proposes any increase in rates, it shall comply with Rule 3.2(a).

Applicant's proposed services will be offered on a non-discriminatory basis. Applicant requests a waiver of filing a local exchange tariff describing its services, rates and terms and conditions but rather on a de-tariffed basis. Applicant intends to offer its services at rates that are competitive with the rates of the incumbent local exchange carriers in California. Applicant will provide information regarding its rates, terms and conditions of service on its website at www.sequoiawireless.com. Applicant's contracts with customers will be consistent with the consumer protection rules established in D.98-08-031 and contain all applicable commission fees and surcharges.

14. General Order 104-A Statement [Rule 3.1(i)]

The applicant must provide a statement corresponding to the statement required by Section 2 of General Order No. 104-A, as to all known matters which both (a) are designated by said section for inclusion in the annual report but occurred or were proposed subsequent to the period covered by the last previous annual report filed by the applicant and (b) are, or will be, connected with the construction or extension proposed in the application; or, if no such matters are known to have so occurred or are then known to be proposed, a statement to that effect; provided, that an applicant whose capital stock, or that of its parent company, is listed on a "national securities exchange," as defined in the Securities Exchange Act of 1934 (15 U.S.C. 78(a) et seq.), in lieu of the statement required by this rule shall include in the application, provided, further, that an applicant whose capital stock, or that of its parent company, is registered with the Securities and Exchange Commission (SEC) pursuant to the provisions of Section 12(g) of said Securities Exchange Act of 1934, in lieu of the statement required by this rule shall include by this rule shall include in the application a copy of the latest proxy statement sent to stockholders by it or its parent company, is registered with the Securities and Exchange Commission (SEC) pursuant to the provisions of Section 12(g) of said Securities Exchange Act of 1934, in lieu of the statement required by this rule shall include in the application a copy of the latest proxy statement sent to stockholders by it or its parent company containing the information required by the rules of the SEC if not previously filed with the Commission.

Sequoia Wireless was exempt from filing an annual report in 2023. No known matters, as outlined in Section 2 of General Order No. 104-A, have occurred or been proposed subsequent to the period covered by the last annual report filed, which would impact or be associated with the project proposed in this application.

Additionally, Sequoia Wireless is wholly owned by R Indran C Nelson (100%), is not owned by a parent company, and confirms that its capital stock is not listed on a national securities exchange, nor is it registered with the Securities and Exchange Commission (SEC) under Section 12(g) of the Securities Exchange Act of 1934. Therefore, no proxy statement or other SEC-related documents are required to be submitted with this application.

This statement fulfills the requirements of Section 2 of General Order No. 104-A.

15. Estimated Customer Base [Rule 3.1(j)]

The applicant must provide the estimated number of customers and their requirements for the first and fifth years in the future.

Sequoia Wireless estimates the total number of newly activated residential customers throughout the first year (2025) as 7,784. We further estimate that less churn, our residential customers count at the end of the first year to be 6,528 Subscribers.

Sequoia Wireless estimates the total number of newly activated residential customers throughout the fifth year (2029) as 57,231. We further estimate that less churn, our active residential customers count at the end of the fifth year to be 67,392 Subscribers.

16. Technical and Managerial Competence [D.95-12-056, Appendix C, D. 13-05-035, Rule. 4.A]

The applicant seeking authority to provide local exchange and/or interexchange service must demonstrate that it has the technical and managerial qualifications necessary to provide the proposed services in its service territory. The applicant should provide the following information, but not limited to: the applicant's key management and technical personnel, resumes and biographies of the key management and technical personnel, resumes significant technical and managerial expertise for operating a telecommunications company, consistent with the Commission's requirements.

Applicant has technical and managerial qualifications necessary to provide the proposed services in its service territory. Attachment B is the biography for Applicant's key management and technical personnel, reflecting that the applicant possesses significant technical and managerial expertise for operating a telecommunications company, consistent with the CPUC's requirements. Applicant has been serving customers since January 2024. In August, we were authorized as a California LifeLine Service Provider, which we are one of only 15 authorized in the state to offer Wireless services to those eligible for LifeLine in California. We also have a backend of technical expertise from Telgoo5 and PWG to consult as needed. Patrick Hardy has been in the telecom industry for over 18 years in positions ranging from regulatory compliance to owning and managing various telecommunications companies and has the proven qualifications in Wireless Facilities Infrastructure.

17. Managerial Competence [D.95-12-056, Appendix C, D. 13-05-035, Rule. 4.A]

Neither applicant, any of its affiliates, officers, directors, partners, agents, or owners (directly or indirectly) of more than 10% of applicant, or anyone acting in a management capacity for applicant: (a) held one of these positions with a company that filed for bankruptcy; (b) been personally found liable, or held one of these positions with a company that has been found liable, for fraud, dishonesty, failure to disclose, or misrepresentations to consumers or others; (c) been convicted of a felony; (d) been (to his/her knowledge) the subject of a criminal referral by judge or public agency; (e) had a telecommunications license or operating authority denied, suspended, revoked, or limited in any jurisdiction; (f) personally entered into a settlement, or held one of these positions with a company that has company that has entered into settlement of criminal or civil claims involving violations of sections 17000 et seq., 17200 et seq., or 17500 et seq. of the California Business & Professions Code, or of any other statute, regulation, or decisional law relating to fraud, dishonesty, failure to disclose, or misrepresentations to consumers or other sequated industries; or (h) entered into any statute, law, or rule pertaining to public utilities or other regulated industries; or (h) entered into any settlement agreements or made any voluntary payments or agreed to any other type of monetary forfeitures in resolution of any action by any regulatory body, agency, or attorney general.

18. Request for Exemptions (To be included only if applicant requests treatment as an NDIEC)

The applicant may request that, in connection with its authorization as a CLEC, it be accorded the same streamlined regulatory treatment previously accorded to other CLECs as a non-dominant interexchange carrier as set forth in D.96-02-075 and as adopted by NDIECs.

The Applicant, Sequoia Wireless, hereby submits this request for exemptions in connection with its application for authorization as a Competitive Local Exchange Carrier (CLEC). The Applicant seeks to be accorded the same streamlined regulatory treatment previously accorded to other CLECs as a Non-Dominant Interexchange Carrier (NDIEC), as outlined in Decision D.96-02-075. Sequoia Wireless intends to provide competitive telecommunications services in California, which will enhance service availability and options for consumers. In alignment with this goal, the Applicant requests the following exemptions:

Sequoia Wireless seeks exemption from the provisions of PU Code Sections 816-830 (pertaining to the issuance of stocks and securities) and PU Code Section 851 (pertaining to the transfer or encumbrance of utility assets when such transfer or encumbrance is for the purpose of securing debt). The Commission has previously concluded that NDIECs should be exempt from the provisions and requirements of PU Code Sections 816-830 and 851 (insofar as these sections pertain to the issuance of securities and transfer or encumbrance of utility property for purposes of securing debt) in D.85-07- 081, D.85-11-044 and D.86-08-057, as confirmed by D.90-09-032. This exemption was extended to CLCs in D.96-02-072, Ordering Paragraph 18.

Sequoia Wireless seeks exemption from any requirement to maintain its books and records in accordance with the Uniform System of Accounts specified in Title 47 I.E. Part 32 consistent with D.99-02-038, which relieved CLCs that are not part of an incumbent local exchange carrier (ILEC) corporate entity from the requirement to keep their books of account in conformance with the Uniform System of Accounts.

19. Request authority for intra-LATA and inter-LATA

Applicant can also request in its CLC application authority for intra-LATA and inter-LATA toll authority with the CLC application at no extra cost.

Sequoia Wireless included our request in the form of a letter found under Attachment H, which is our request for Intra-LATA and Inter-LATA Toll Authority.

20. Tariffs

The applicant must attach a copy of its draft tariff that describes all the services and sample rates that it intends to offer. In order to draft a tariff that complies with the CPUC's requirement, the following documents are important to obtain and review before drafting. Applicant may request for exemption from tariff requirements pursuant to GO 96-B Telco Industry Rule 5.

Applicant respectfully requests waiver from filing tariffs describing its services, rates and terms and conditions, but rather operate on a de-tariffed basis. We respectfully request that the CPUC grant Sequoia Wireless an exemption from tariff filing requirements under Requirement 19, pursuant to Telco Industry Rule 5. We believe this exemption aligns with regulatory goals and upholds consumer protection without the need for tariff filings.

21. Continuous Performance Bond Requirement (D.13-05-035)

D.13-05-035 requires new and existing CPCN holders to submit a continuous performance bond in the amount of \$25,000 issued by a corporate surety company authorized to transact surety business in California with the Commission listed as an obligee on the bond.

Sequoia Wireless as submitted to the CPUC a continuous performance bond in the amount of \$25,000 issued by a corporate surety company authorized to transact surety business in California with the Commission listed as an obligee on the bond. A copy of the bond is included under Attachment I.

22. SB 960 Compliance – Scoping Memorandum Information (Rule 2.1(c))

In accordance with the Commission's Rules, Applicant provides the following information:

a. 



STATEMENT EXPLAINING HOW THE COMPANY'S OPERATING PROCEDURES ENSURE COMPLIANCE WITH THE FCC'S CPNI RULES

I. Customer Proprietary Network Information ("CPNI")

CPNI is defined in Section 222(f) of the Communications Act as (A) information that relates to the quantity, technical configuration, type, destination, and amount of use of a telecommunications service subscribed to by any customer of a telecommunications carrier, and that is made available to the carrier by the customer solely by virtue of the carrier-customer relationship; and (B) information contained in the bills pertaining to telephone exchange service or telephone toll service received by a customer of a carrier (except that CPNI does not include subscriber list information).

Generally, CPNI includes personal information regarding a consumer's use of his or her telecommunications services. CPNI encompasses information such as: (a) the telephone numbers called by a consumer; (b) the length of a consumer's phone calls, and (c) the telecommunications and information services purchased by a consumer.

II. Use of CPNI is Restricted

The Company recognizes that CPNI includes information that is personal and individually identifiable, and that privacy concerns have led Congress and the FCC to impose restrictions upon its use and disclosure, and upon the provision of access to it by individuals or entities inside and outside the Company.

The Company has designated a CPNI Compliance Officer who is responsible for: (1) communicating with the Company's attorneys and/or consultants regarding CPNI responsibilities, requirements and restrictions; (2) supervising the training of Company employees and agents who use or have access to CPNI; and (3) receiving, reviewing and resolving any questions or issues arising within the Company regarding use, disclosure, or provision of access to CPNI.

Company employees and agents that may deal with CPNI have been informed that there are substantial federal restrictions upon CPNI use, distribution and access. In order to be authorized to use or access the Company's CPNI, employees and agents must receive training with respect to the requirements of Section 222 of the Communications Act and the FCC's CPNI Rules (Subpart U of Part 64 of the FCC Rules).

III. Permissible Uses of CPNI

Company employees and agents are strictly prohibited from using CPNI, and from providing CPNI to individuals or entities inside or outside the Company, except as follows:

The Company may, after receiving an appropriate request from a customer, disclose or provide the customer's CPNI to any person or entity designated by the customer. Any and all such customer requests: (1) must be made in writing; (2) must include the customer's correct billing name and address and telephone number; (3) must specify exactly what type or types of CPNI must be disclosed or provided; (4) must specify the time period for which the CPNI must be disclosed or provided; and (5) must be signed by the customer.

- 2. In the absence of an appropriate written request from the customer, the Company may provide the customer's phone records or other CPNI to a law enforcement agency only in response to a warrant or subpoena that specifies the particular CPNI to be furnished.
- 3. The Company and its authorized employees may use, disclose or permit access to CPNI to provide services necessary to, or used in, the provision of the telecommunications service from which the CPNI is derived.
 - a. The FCC has noted the publishing of directories as an example of this permitted use.
 - b. The FCC has indicated that telecommunications carriers may use, disclose or permit access to CPNI, without customer approval, to provide inside wiring installation, maintenance, and repair services.
 - c. The FCC has stated that local exchange carriers and commercial mobile radio service providers may use CPNI, without customer approval, to market "adjunct-to-basic" services such as speed dialing, computer-provided directory assistance, call monitoring, call tracing, call blocking, call return, repeat dialing, call tracking, call waiting, caller ID, call forwarding, and certain Centrex features.
 - d. Any other use, disclosure or provision of CPNI under this "necessary to or used in the provision of" category must be expressly approved in writing by the Company's CPNI Compliance Officer.
- 4. The Company, its authorized employees and its billing agent may use CPNI to initiate, render, bill and collect for telecommunications services.
- 5. The Company may use CPNI to protect the Company's rights or property, and to protect users and other carriers from fraudulent, abusive or illegal use of (or subscription to) the telecommunications service from which the CPNI is derived.
- 6. When an existing customer calls the Company to inquire about or order new, additional or modified services (in-bound marketing), the Company may use the customer's CPNI to assist the customer for the duration of the customer's call if the Company provides the customer with the oral notice required by Sections 64.2008(c) and 64.2008(f) of the FCC's Rules.
- 7. The Company has adopted a policy that it does not and will not use, disclose, or permit access to CPNI in connection with Company-initiated marketing of services to which a customer does not already subscribe from the Company (out-bound marketing).

IV. CPNI Compliance Officer

In addition to the specific matters required to be reviewed and approved by the Company's CPNI Compliance Officer, employees and agents are strongly encouraged to bring any and all other questions, issues or uncertainties regarding the use, disclosure, or access to CPNI to the attention of the Company's CPNI Compliance Officer for appropriate investigation, review and guidance. The extent to which a particular employee or agent brought a CPNI matter to the attention of the CPNI Compliance Officer and received appropriate guidance is a material consideration in any disciplinary action brought against the employee or agent for impermissible use, disclosure or access to CPNI.

V. Disciplinary Procedures

The Company has informed its employees and agents that it considers compliance with the Communications Act and FCC Rules regarding the use, disclosure, and access to CPNI to be very important.

Violation by Company employees or agents of such CPNI requirements will lead to disciplinary action (including remedial training, reprimands, unfavorable performance reviews, probation, and termination), depending upon the circumstances of the violation (including the severity of the violation, whether the violation was a first time or repeat violation, whether appropriate guidance was sought or received from the CPNI Compliance Officer, and the extent to which the violation was or was not deliberate or malicious).
