Subject: Email Ruling Off-Calendaring Evidentiary Hearing

Parties to the Service List of Application (A.)23-12-014:

In view of the January 8, 2025 filing of Pacific Gas and Electric Company (PG&E), this ruling takes the January 16, 2025 Evidentiary Hearing off calendar.

The January 8, 2025 filing presented certain stipulations reached between PG&E and California Community Choice Association (CalCCA). The stipulations, as presented in the January 8, 2025 filing, lack adequate clarity. There is also some lack of clarity as to potential implications of the stipulations.

Parties are therefore instructed to be prepared to provide clarifications regarding the stipulations and potential implications of the stipulations during the January 13, 2025 STC.

A subsequent ruling will be issued based upon Parties' January 13, 2025 STC representations and clarifications. That subsequent ruling will address pending issues and schedule adjustments, if any, that are necessary to ensure that this proceeding advances without undue delay.
