CARRIER TELEPHONE CORPORATION PURSUANT TO THE PROVISIONS OF

Good Methods Global Inc. (the “Company”) respectfully requests to withdraw, without prejudice, the Application for Registration as an Interexchange Carrier Telephone Corporation pursuant to the Provisions of Public Utilities Code Section 1013 filed on August 8, 2024, Application No. 24-06-011, with the California Public Utilities Commission (“CPUC”). On account of the Company being designated a Nomadic Interconnected Voice Over Internet Protocol (“VoIP”) provider and decision 24-11-003 (D.24-11-003), adopted on November 7, 2024, all telephone corporations which only provide Nomadic Interconnected VoIP are to submit a Communications Division Form, rather than submit an application pursuant to Public Utilities Code Section 1013.
