**MOTION FOR PARTY STATUS OF PACIFIC COMMUNITY FUND**

**I. Introduction**

Pacific Community Fund respectfully moves for party status in this proceeding in accordance with Section 1.4 of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure.

**II. Interest in this Proceeding**

A. Pacific Community Fund, formerly the National Asian American Coalition, is a California nonprofit public benefit corporation, working to provide economic empowerment to low- and moderate-income families and communities. Specific objectives of Pacific Community Fund include: increasing sustainable and responsible home ownership for low to moderate income families; providing technical assistance for small business development; and advocacy for low and moderate income communities on a broad range of consumer issues before governmental bodies. Pacific Community Fund endeavors to plan, maintain and improve low and affordable residential housing and related facilities, preserve and revitalize communities, and protect and ensure the well-being of residents.

There is currently an urgent need for electric vehicle (EV) charging infrastructure in low-income communities of color, where access to clean transportation options remains limited. Pacific Community Fund supports the expansion of EV charging infrastructure to these communities.

**B.** Pacific Community Fund aims to advocate for the distribution of the appropriate share of public money and EV charging infrastructure to these historically underserved communities of color throughout California. The current state of EV charging infrastructure deployment in these communities is inadequate and this proceeding can serve to help remedy this deficiency.

Since May of 2023, Pacific Community Fund has had a contract in place with PG&E to raise public awareness of tax credits for the purchase of used electric vehicles. The inaccessibility of publicly available electric vehicle chargers undermines the public's ability to access these tax credits, particularly within the historically underserved, low to moderate-income communities. This is especially true at present, when the California Legislature has not mandated that multi-family apartment owners install an adequate number of electric vehicle chargers at their complexes. Pacific Community Fund strives to remedy this through its involvement in this proceeding.
