ADMINISTRATIVE LAW JUDGE'S RULING SETTING A WEBEX PREHEARING CONFERENCE

A.24-03-009 was filed on March 12, 2024, by Pacific Gas and Electric Company (PG&E) requesting approval under Public Utilities Code Section 851 to lease entitlements to transmission projects to Citizens Energy Corporation.
