TURN Motion to Clarify and/or Modify the Scoping Memo

To the Parties and Service List:

On April 22, 2025, The Utility Reform Network (TURN), a protestant in this proceeding, filed a Motion to Clarify and/or Modify the Scoping Memo for this proceeding. The applicant, Pacific Gas & Electric Company (PG&E), responded with a written opposition to the TURN motion filed only two days thereafter, on April 24, 2025. Both TURN and PG&E urge the Commission to act quickly on the TURN motion. Due to the need for the parties and the Commission to prepare for an imminent evidentiary hearing in this proceeding, an expedited ruling on TURN's motion is necessary. To accomplish the goal of an expedited ruling on the merits of the TURN motion, the following briefing schedule must be followed: (1) parties wishing to file a response to TURN's motion shall do so by close of business on Tuesday, April 29, 2025; and (2) TURN may file a reply memorandum no later than close of business on Thursday, May 1, 2025. I will endeavor to issue my ruling as quickly as possible.

ACCORDINGLY, it is ordered that the parties follow the briefing schedule set forth in the preceding paragraph of this ruling.
