Good afternoon ALJ DeAngelis,

We are pleased to inform you that the parties have reached a settlement in principal on all of PG&E's financial recovery requests in A.23-012-001, except for the Vegetation Management Balancing Account (VMBA). In addition to PG&E's VMBA request, there are also policy issues still in dispute that will require briefing. Given the time needed to complete the drafting and filing of a
