Subject: A.25-05-001: Email Ruling Confirming PHC Date and Time and

Directing Parties to File Pre-Hearing Conference Statements

To the Service List of A.25-05-001:

This email ruling addresses the request filed by Julia Mass, who intends to represent the Utility Workers of America, AFL-CIO, Local 132 and International Chemical Workers Union Local 350 c, 478c, and 995c (collectively, the Unions) in Application (A.)25-05-001 during the Prehearing Conference (PHC) set for July 11, 2025.

Julia Mass states that she is unable to attend the prehearing conference (PHC) as scheduled due to travel conflicts and requests a change in the PHC date and time.

This ruling amends the June 17, 2025, Administrative Law Judge (ALJ) ruling setting the prehearing conference for A.25-05-001 to authorize all parties to this proceeding to provide PHC statements on or before noon Pacific Daylight Time (PDT) on July 10, 2025.

The time and date of the PHC for A.25-05-001 was noticed on June 17, 2025, to ensure that parties can participate pursuant to the Commission's Rules of Practice and Procedure Rule 7.2, which requires the Commission to hold a PHC between 45-60 days after the initiation of the proceeding.

To accommodate initial record building for this proceeding, I find it beneficial to authorize all parties to A.25-05-001 to provide PHC statements on or before noon

on July 10, 2025, PDT. Each party's PHC statement may address its proposed schedule and provide proposals of the issues to be considered in A.25-05-001.

I also note that Julia Mass may seek another representative to speak on the behalf of the Unions during the PHC.

I have already received notice that the applicant, Southern California Gas Company; the Public Advocates Office at the California Public Utilities Commission; the Small Business Utility Advocates; and The Utility Reform Network will be represented at the PHC.

The PHC in A.25-05-001 will be held telephonically, as currently scheduled, at 10:00 a.m. PDT on July 11, 2025, through the teleconference details provided below, which are also available on the Commission's Daily Calendar:
