ADMINISTRATIVE LAW JUDGES' RULING NOTICING ORAL ARGUMENT

1. Summary

This ruling gives notice that an in-person oral argument will be held in this proceeding on Monday, August 11, 2025, in the Commission's San Francisco auditorium at 1:00 p.m.

The August 11, 2025 oral argument is available only to those who have existing party status to this proceeding. Those who are not already existing parties to this proceeding shall not participate in the oral argument. The oral argument is in-person; no party shall be allowed to participate remotely.

A quorum of the Commissioners will be in attendance, but no decisions shall be made.

2. Notice of Oral Argument

In its July 15, 2024 opening brief, Southern California Edison Company (SCE or Applicant) requested that oral argument be held in this proceeding pursuant to Rule 13.14 of the Commission's Rules of Practice and Procedure and Section 5 of the Scoping Memo and Ruling of the Assigned Commissioner. Notice is hereby given that an in-person oral argument will be held in this proceeding on Monday, August 11, 2025, in the Commission's Auditorium located at 505 Van Ness Avenue, San Francisco, California. The oral argument will begin at 1:00 p.m.

The August 11, 2025 oral argument is available only to those who have existing party status to this proceeding. Those who are not already existing parties to this proceeding shall not participate in the oral argument. The oral argument is in-person; no party shall be allowed to participate remotely. A quorum of Commissioners will be in attendance, but no decisions shall be made.

An agenda for the oral argument will be served before the date of the event. It is expected that the Applicant, SCE, will be first to speak at the oral argument, followed by the other parties, and then a short rebuttal by the Applicant.

Parties who wish to address the Commission on the issues in this proceeding shall send an e-mail to Administrative Law Judges Colin Rizzo (Colin.Rizzo@cpuc.ca.gov) and Ehren Seybert (Ehren.Seybert@cpuc.ca.gov) no later than August 4, 2025. A copy of the e-mail shall also be served on the service list for this proceeding.

In the e-mail, parties shall include the name, telephone number, and e-mail address of the representative that will be speaking, as well as the estimated time they are requesting to speak. Parties shall be represented by a single speaker. Parties speaking times shall be based on the time allotted. Requested speaking times may be adjusted if necessary.
