JOINT MOTION TO MOVE EXHIBITS INTO EVIDENCE

I. INTRODUCTION

Pursuant to Rule 13.8(c) of the Rules of Practice and Procedure (“Rules”) of the California Public Utilities Commission (“Commission”) and in accordance with the direction of the assigned Administrative Law Judge (“ALJ”) Alberto Rosas during the May 21, 2025 evidentiary hearing, California Water Service Company (“Cal Water”), the Public Advocates Office at the California Public Utilities Commission (“Cal Advocates”), California Water Association (“CWA”), and National Association of Water Companies (“NAWC”) (collectively, “the Parties”) submit this Motion to Move Exhibits into Evidence (“Motion”) in the above captioned proceeding. Specifically, the Joint Parties respectfully request that the Commission move the exhibits into evidence as shown in the Exhibit List attached here as **Attachment A**.

II. DISCUSSION AND STATEMENT IN SUPPORT OF MOTION

A. Additional Documents Added To Exhibit List

Cal Water and Public Advocates have developed two lists of issues and capital projects that are presented in this proceeding as “Joint Exhibits” (“Joint” in this case referring only to Cal Water and Cal Advocates). Draft versions of these lists were provided as Attachments A and B

to the Joint Motion for Evidentiary Hearings filed on April 22, 2025. Updated versions of these lists are being provided to the Service List concurrently with this Motion, and are listed in Attachment A as the following documents:

- **Exhibit Joint-01** – List of Disputed Issues and Capital Projects (“Disputed Issues List”)
- **Exhibit Joint-02** – List of Undisputed Issues and Partially Resolved Capital Projects (“Undisputed Issues List”)

Disputed Issues List – Issues 1 through 37 on the Disputed Issues List are addressed in Parties’ Opening Briefs under the identified Scoping Issues and according to the briefing structure agreed-upon by the Parties. As discussed in Issue 40 and at the top of page 3, the subsequent pages consist of the capital projects in dispute as reflected in the Parties’ Results of Operations (“RO”) Models. This list was generated by comparing the dollar amounts proposed by each party according to what is reflected in their most recent RO models.¹ For most of these projects, the only disputes are global capital issues (issues that impact many capital projects such as contingency), so briefs address the disputed global issues rather than specific projects. Other projects are grouped as capital programs, and briefs accordingly address the capital programs. Finally, project-specific disagreements are addressed individually in briefs and are grouped by operating district.

Undisputed Issues List – The Parties anticipate memorializing the Undisputed Issues List in a partial settlement agreement that will be filed by August 1, 2025.

B. Description of the Exhibit List

Each of the exhibits identified in Attachment A are prepared testimonies or accompanying exhibits served by the respective parties in this proceeding and the public versions of the documents have been uploaded as supporting documents pursuant to Rule 13.7(f). In turn, Rule 13.8(c) allows prepared testimony and accompanying exhibits to be “offered and received into evidence without direct or cross examination absent objection by any party.”² The Parties

¹ At the end of the list, note that the final eight (8) projects are for the installation of AMI meters. As explained in Parties’ Opening Briefs, the budgets for these projects may be in dispute depending upon the ratemaking approach the Commission adopts for recovering 100% of the project costs.

² Direct examination of certain witnesses was conducted the evidentiary hearings held in May 2025 and the assigned ALJ posed questions to those witnesses. However, the Parties have agreed to mutually waive cross-examination of witnesses.

are the only active parties to this proceeding and do not have any objections to the admission of this into the record. The Parties are also not aware of any objections that would be made to receiving these exhibits into evidence.
