**Subject:** Ruling Requiring Response to Inquiry A.25-02-017 and A.25-02-018 (Consolidated)

Good afternoon. In order to properly consider consolidated Applications (A.) 25-02-017 and A.25-02-018, the California Public Utilities Commission requires further information. The Applicants shall file and serve their response to this inquiry within 10 days.

1. At Item 6 of each application, the Applicants state that they will provide wholesale voice service to their affiliate, Spectrum Advanced Services, LLC. But at Attachment B of each application, Applicants state that they will provide service to Charter Fiberlink CA-CCO, LLC (A.25-02-017) and Bright House Networks Information Services (California), LLC (A.25-02-018).
  - a. Clarify which entity each Applicant will be providing wholesale service to. Explain

The Applicants in the consolidated proceedings A.25-02-017 and A.25-02-018 shall file and serve their response to the above inquiry within 10 days.
