APPLICATION

The application of CONTINENTAL SHUTTLE LLC hereinafter referred to as “applicant”, respectfully states:

The exact name of applicant is CONTINENTAL SHUTTLE LLC, a Delaware LLC. A copy of the Delaware Registration, and the California Certificate of Status as a registered Out of State LLC are attached as Exhibit A.

The principal place of business is 11281 Crystal Oaks Way, San Diego CA 92131, and the phone number is (858)275-4422.

The Chief Executive Officer is Asif Aejaaz, and his address is 11281 Crystal Oaks Way, San Diego CA 92131.

Pursuant to Public Utilities Code Section 1031, applicant requests a certificate of public convenience and necessity to establish and operate as a scheduled passenger stage corporation between points in San Diego, California, Escondido, California, and Los Angeles International Airport. The

1 specific points in San Diego are 5563 Balboa Avenue, San Diego CA 92111, and 9650 Mira Mesa
2 Boulevard, San Diego CA 92126. The specific address in Escondido is the Escondido Transit Center at
3 700 W. Valley Parkway, Escondido CA 92025.

4 The proposed fares to be assessed for this service, and rules and regulations governing the same are
5 as set forth in Exhibit B.

6 The proposed time schedule between the points to be served is set forth in Exhibit C attached hereto.

7 A map showing the proposed route of operations is attached hereto as Exhibit D

8 A description of the equipment to be operated in the proposed service is as shown in Exhibit E
9 attached hereto.

10 A financial statement of applicant is attached hereto as Exhibit F.

11 Public convenience and necessity require a grant of authority requested by the applicant for the
12 following reasons:

13 A. Current operators serving these origin points and destinations take a coastal route (I-5)
14 that is less convenient to a number of potential passengers. Applicant believes proposed route, utilizing I-
15 15 and other inland highways within San Diego County before traveling west to proceed on the I-5 will
16 provide a competitive and reliable service between these points in San Diego and Los Angeles International
17 Airport.

18 B. Per the above, including inter alia Exhibit F, applicant believes they are financially and
19 organizationally capable of conducting an operation that complies with the rules and regulations of the
20 Department of the California Highway Patrol (CHP) governing highway safety.

21 C. The applicant is committed to observing federal and state hours of service regulations.

22 D. Applicant has a preventive maintenance program in effect including staff inspections
23 (including the driver) recorded on company forms, with maintenance and repair to be performed under
24 contract with Mercedes-Benz of San Diego. Applicant has a backup vehicle plan with arrangements made
25 for rental through ASAP Rent A Van, 8869 Balboa Ave Ste A, San Diego, California..

26 E. Applicant has a safety education and training program in effect for all employees.

27 F. Applicant has a program to monitor the driving records of those operating vehicles on
28 the company's behalf. Applicant has implemented a program for Controlled Substance and

1 Alcohol Testing, including pre-employment, incident or accident, and legally required random testing.

2 G. Applicant agrees to maintains its passenger vehicles in safe operating condition and in
3 compliance with motor vehicle safety laws and regulations.


4 H. Applicant has obtained Workers Compensation and Employers' Liability insurance as
5 shown on the Certificate of Liability Insurance attached at Exhibit G.

7 The names of all county and city governmental entities, regional transportation planning agencies
8 and public transit operators within whose boundaries passengers will be loaded or unloaded are attached
9 hereto as Exhibit H.



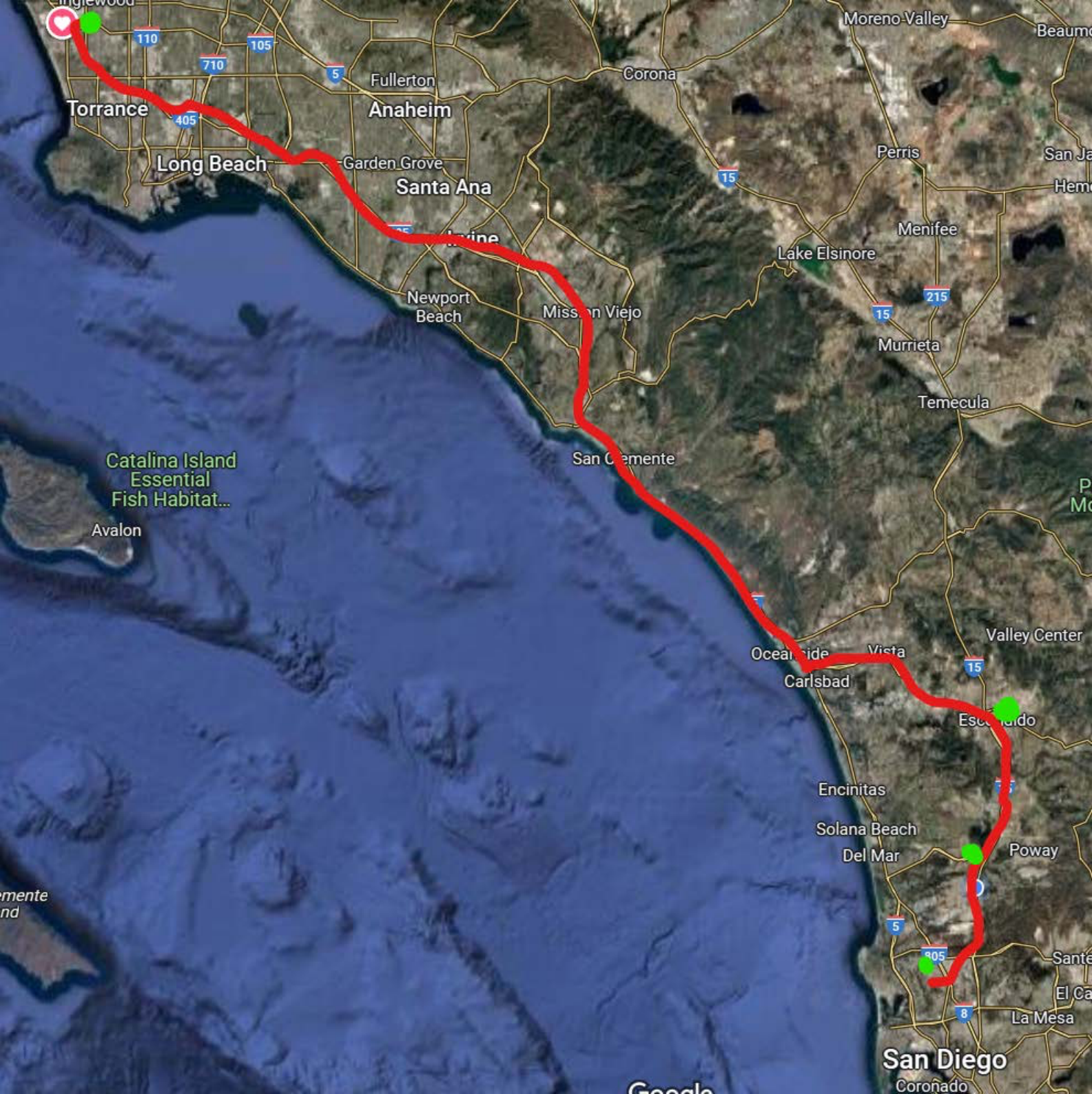


