PG&E unlawfully securitized and monetized private trust property, including my utility account, billing contract, financial identifiers, and name, without consent or lawful title to the recovery property. This violated Electric Rule 9.M, Rule 27, and California Civil Code §§ 1798.81–.85. PG&E issued securitization bonds backed by unlawfully obtained customer contracts while continuing to bill me as if nothing had been paid. The company is double-dipping and profiting from unauthorized securities while harming the trust. I request a full investigation, restitution, and immediate cessation of all billing activity related to the affected account. PG&E unlawfully securitized and monetized property of The Cytah Flores Legacy Trust — specifically the utility account, billing contract, trust-held legal name, and associated financial identifiers — without consent, contract, or lawful title. These actions constitute unauthorized use of trust property, breach of privacy, and conversion of assets in violation of: California Civil Code §§ 1798.81-.85 (NPI misuse) California Civil Code §§ 2223, 2224 (constructive trust/wrongful holding) California Civil Code § 1550 and § 1689 (invalid contracts) The California Consumer Privacy Act (CCPA) Truth in Lending Act (15 U.S.C. § 1601 et seq.) 18 U.S.C. § 1343 (wire fraud through unauthorized use of financial accounts) Complainant seeks full restitution, enforcement of customer protections, a complete accounting of profits gained from monetization of trust property, and a CPUC order to cease all unlawful billing and securitization activity.
