# ADMINISTRATIVE LAW JUDGE'S RULING RESETTING PREHEARING CONFERENCE AND REQUESTING JOINT PREHEARING CONFERENCE STATEMENT

### **Summary**

This ruling reschedules a remote prehearing conference (PHC) at 10:00 a.m. on Wednesday, November 12, 2025. This ruling also directs parties to meet and confer prior to the PHC, and submit a Joint PHC Statement no later than October 31, 2025.

## 1. Prehearing Conference

The remote PHC is rescheduled for November 12, 2025, at 10:00 a.m. The PHC will address the status, scope, schedule, and other issues in this proceeding.

#### 2. Joint Prehearing Conference Statement

Ikigai Hot Springs LLC (Complainant) and California Hot Springs Water and Sewer Service (Defendant) shall meet and confer regarding the below list of topics, and shall make a good faith effort to resolve all issues that can reasonably be resolved through the meet and confer process. Complainant and Defendant shall file and serve a Joint PHC Statement addressing the below issues, not to exceed seven pages, no later than October 31, 2025.

The list of topics to be addressed in a joint PHC statement are:

- (1) The need for evidentiary hearings;
- (2) A proposed scope of issues to be considered in the proceeding;
- (3) A proposed schedule for the proceeding;
- (4) Discovery issues, and how remaining discovery issues will be resolved; and
- (5) A description of other matters the parties would like to address that will further the prompt resolution of this matter.

Parties are advised that they should not wait for the PHC to commence discovery.

Therefore, IT IS RULED that:

- 1. The California Public Utilities Commission has set a prehearing conference in above-captioned matter for November 12, 2025 at 10:00 a.m.
- 2. Parties shall meet and confer prior to the scheduled prehearing conference (PHC). Parties shall file and serve a Joint PHC Statement on the issues set forth in this ruling no later than October 31, 2025.
