**JOINT STATUS REPORT**

Pursuant to the *Email Ruling Canceling the Evidentiary Hearing on October 31, 2025, and Making Further Adjustments to the Schedule for This Proceeding* issued by Administrative Law Judge (ALJ) Ferguson on October 7, 2025 (ALJ Ruling), Pacific Gas and Electric Company (PG&E), Southern California Gas Company (SoCalGas), San Diego Gas & Electric Company (SDG&E), Southwest Gas Corporation (Southwest Gas) (collectively Joint IOUs), California Hydrogen Business Council (CHBC), Leadership Counsel for Justice and Accountability and Orange Cove United (LCJA/OCU), Public Advocates Office at the California Public Utilities Commission (Cal Advocates), Sierra Club, Small Business Utility Advocates (SBUA), Utility Consumers' Action Network (UCAN), and Wild Tree Foundation (Wild Tree) (collectively including the Joint IOUs, the Parties) provide a status update (Status Update) regarding the negotiations between and among counsel for the parties that were discussed at the Status Conference on October 7, 2025 (Status Conference).<sup>1</sup>

**I. STIPULATIONS OF THE PARTIES**

As to Joint IOUs and California Hydrogen Business Council (CHBC), on the one hand, and Leadership Counsel for Justice and Accountability and Orange Cove United (LCJA/OCU), Sierra Club, Utility Consumers' Action Network (UCAN), and Wild Tree Foundation (Wild Tree) on the other hand, these parties have stipulated, without contingencies, to:

- The mutual waiver of cross-examination of witnesses;
- The withdrawal of the Joint IOUs' *Motion in Limine to Exclude Evidence Regarding Hydrogen Blending as a Matter of Macro-Level Decarbonization Policy* filed on October 3, 2025 (Motion in Limine);
- The filing of a Joint Motion for the admission of each other's testimony and exhibits into the record to be submitted by October 29, 2025; and
- The Joint IOUs' responding in good faith to data requests and the admission of those data request responses into the record.

The Parties further agree that matters of relevance of testimony to the scope of proceeding may be briefed, including with regards to the issues raised in the Motion in Limine.<sup>2</sup>

The Joint IOUs, Cal Advocates, and SBUA have agreed to mutually waive cross-examination and to not object to admission of each of the other parties' exhibits to the evidentiary record. These Parties further agree to the filing of a Joint Motion for the admission of each other's testimony and exhibits into the record to be submitted by October 29, 2025. SBUA will be submitting an additional Data Request to SoCalGas and Southwest Gas in lieu of evidentiary hearings.

## **II. HEARINGS**

Because the Parties have stipulated to mutual waivers of cross-examination and admission of the other Parties' exhibits into the evidentiary record, the Parties agree that evidentiary hearings are not necessary in this proceeding.
