ADMINISTRATIVE LAW JUDGE'S RULING SETTING PREHEARING CONFERENCE

This ruling sets a remote prehearing conference (PHC) in this proceeding for **10:00 a.m.** on **Monday, November 17, 2025**. The purpose of the remote PHC is to address the scope, schedule, and other procedural matters for this proceeding. This ruling also provides guidelines for participants of the PHC.

B. Guidelines for the PHC

Oral motions for party status will not be entertained during the PHC.

Entities may signal their interest in formal party status by filing a written motion for party status explaining their interest in participating, in accordance with

Rule 1.4 of the Commission's Rules of Practice and Procedure.

Entities need not have achieved party status prior to the PHC in order to speak at the PHC. Each organization must select one individual to speak on its behalf during the PHC. Entities are asked to designate the specific individual to Administrative Law Judge (ALJ) Debbie Chiv at Debbie.Chiv@cpuc.ca.gov with a cc: to the proceeding analysts Nicholas Bonino at Nicholas.Bonino@cpuc.ca.gov with a cc: to the proceeding analysts Nicholas Bonino at Nicholas.Bonino@cpuc.ca.gov and Sam Frank at Sam.Frank@cpuc.ca.gov, by no later than 5:00 p.m. on November 5, 2025, with the following subject line: "R.25-10-003: Designated Representative for PHC." This e-mail should contain the name of the representative, title, how the speaker wishes to be addressed (including preferred pronouns, if desired, and/or correct pronunciation of the name), the speaker's e-mail address and phone number, and the name of the organization being represented.

Representatives are reminded that court reporters will be transcribing the PHC and therefore, speakers must adhere to the following rules:

- 1. Speak only when addressed by the ALJ;
- 2. Identify yourself before speaking and turn on your camera (each time);
- 3. Mute yourself when not speaking; and
- 4. Log in to the WebEx link **30 minutes** prior to the PHC to address connectivity issues.

Shortly before the PHC, an e-mail will be sent to the designated participants with the Panelist invitation link, the order in which participants will be able to speak at the PHC, and an agenda for the PHC.

Due to the large number of expected participants, parties should prepare remarks to focus only on their most important concerns and avoid repeating points made by other parties, if possible. Participants should be prepared to discuss any and all issues regarding the scope of issues, categorization of the proceeding, schedule, timing and need for evidentiary hearings, and any other issues directly related to the case management of the proceeding.

Parties seeking expedited transcripts should advise the Chief Hearing Reporter via e-mail at reporting@cpuc.ca.gov no later than three days prior to the first day of the prehearing conference.

As a courtesy, this ruling will be served on the service list of Rulemaking 23-10-011, the predecessor Resource Adequacy rulemaking.

IT IS RULED that:

- 1. A PHC will be held on WebEx beginning at 10:00 a.m. on Monday, November 17, 2025, to discuss the scope, schedule, and other procedural matters for this proceeding.
- 2. Entities wishing to designate a single speaker representative at the PHC shall e-mail the Administrative Law Judge by no later than 5:00 p.m. on November 5, 2025 at Debbie.Chiv@cpuc.ca.gov, with a cc: to Nicholas Bonino at Nicholas.Bonino@cpuc.ca.gov and Sam Frank at Sam.Frank@cpuc.ca.gov, with the name, title, e-mail address, phone number, and organization being represented.
