ADMINISTRATIVE LAW JUDGE'S RULING GRANTING JOINT MOTION FOR ADMISSION OF EXHIBITS INTO THE EVIDENTIARY RECORD

On October 6, 2025, pursuant to Rule 13.8(c) of the Commission's Rules of Practice and Procedure, Southern California Edison Company (SCE), Calstart, Inc. (Calstart), The Utility Reform Network (TURN), Center for Accessible Technology (CforAT), the Public Advocates Office at the California Public Utilities Commission (Cal Advocates), Small Business Utility Advocates (SBUA), California Farm Bureau Federation (CFBF), California City-County Street Light Association (CALSLA), California Large Energy Consumers Association (CLECA), Energy Producers and Users Coalition (EPUC), Electrify America, LLC (Electrify America), EVgo Services, LLC (EVgo), Vehicle-Grid Integration Council (VGIC), Walmart Inc.
