SOUTHERN CALIFORNIA GAS COMPANY'S MOTION TO MODIFY PUBLIC NOTICE REQUIREMENTS FOR PUBLIC PARTICIPATION HEARINGS

Pursuant to Rule 11.1 of the California Public Utilities Commission (Commission or CPUC) Rules of Practice and Procedure and Ordering Paragraph (OP) 6 of the Administrative Law Judge's Ruling Rescheduling Public Participation Hearings, Dismissing Unions' Motion, and Removing Status Conference from the Procedural Schedule (Ruling) issued on October 24, 2025 (Ruling), Southern California Gas Company (SoCalGas) hereby submits this Motion to Modify Public Notice Requirements for Public Participation Hearings (Motion). In the Ruling, Administrative Law Judge Carrie Sisto ordered Public Participation Hearings (PPHs) on January 26, February 2, and February 6, 2026. The Ruling requires SoCalGas to "[p]ost notice of its PPHs on SoCalGas' website and in a prominent location at every branch office and alternate payment locations, so all customers may easily access the notice and participation information..."

The purpose of this Motion is to modify the requirement for SoCalGas to post notices of the PPHs at Authorized Payment Locations (APLs) because SoCalGas is unable to unilaterally post such notices. SoCalGas does not own, rent, or have any contracts with APLs, which typically include check cashing and grocery stores.³ SoCalGas instead has a contract with Fiserv, a company that acts as an intermediary between SoCalGas and APLs; Fiserv has contracts with each APL to allow SoCalGas customers to make payments.⁴ SoCalGas can nonetheless instruct

Fiserv to send a copy of the PPH notice to every APL requesting that they be posted in a prominent location within 30 days from the first PPH scheduled for January 26, 2026. SoCalGas therefore requests that the Ruling be modified so that SoCalGas is allowed to direct Fiserv to ask every APL to post the PPH notices.

SoCalGas respectfully requests that the Motion be granted and allow SoCalGas to instruct Fiserv to request the APLs to post the PPH notices at each APL.

- 2. SoCalGas has a contract with Fisery, a company that acts as an intermediary between SoCalGas and Alternate Payment Locations (APLs). Although SoCalGas does not own or rent any of the APLs, SoCalGas will nonetheless request Fiserv to send a copy of the PPH notice to every APL under its contract with SoCalGas so that they are posted in a prominent location within 30 days from the first PPH scheduled for January 26, 2026.
