To Parties in C2508021

This email ruling serves as notice that the date for the PHC originally set for November 14, 2025 has been changed. The new date for the Prehearing Conference (PHC) in C2508021 is now December 12, 2025. The ruling also acknowledges the request, by Pacific Gas and Electric Company (PG&E) and Southern California Edison Company (SCE) (collectively, the "IOUs"), for extension of the PHC date as moot since the PHC has been rescheduled.

The Commission updated the PHC date, before receiving a request on Friday November 7th from the IOUs for a three-week extension of the November 14, 2025 PHC to December 5, 2025. The change in date was not yet made public on November 7th.

The Commission is aware that PG&E, in compliance with Rule 11.6, informed California Solar & Storage Association (CALSSA) on November 6, 2025, about their position on the proposed request for extension. CALSSA responded on November 7, 2025, stating that it does not support the extension of the Prehearing Conference.

Given the long history of the allegations in the Complaint, it is reasonable to provide more time for the parties and Commission staff to thoroughly review the

Complaint materials to lay a strong foundation for participation in the discussion at the December 12, 2025 PHC.

The date for the PHC in C2508021 is now December 12, 2025.
