**ADMINISTRATIVE LAW JUDGE'S RULING GRANTING SOUTHERN
CALIFORNIA EDISON'S MOTION TO ACCEPT THE AMENDED
DISTRIBUTION UPGRADE PROJECTS REPORT, THE KNOWN LOADS
TRACKING DATASET ASSOCIATED WITH PUBLIC AND
CONFIDENTIAL VERSIONS OF 2025 GRID NEEDS ASSESSMENT,
AND THE DISTRIBUTION UPGRADE PROJECTS REPORT;
AND TO WITHDRAW AND REPLACE PRIOR FILINGS**

This ruling grants the motion of Southern California Edison (SCE) requesting that the Commission accept the amended Distribution Upgrade Projects Report (DUPR) and Known Loads Tracking (KLT) Dataset associated with the Public and Confidential Versions of SCE's 2025 Grid Needs Assessment (GNA) and DUPR; to accept DUPR withdrawal from the record and removal from the Commission's files of the August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR; and replace the August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR with the amended Public and Confidential Versions of SCE's 2025 GNA/DUPR.

**1. Southern California Edison October 20, 2025,
Motion**

SCE filed a motion on October 20, 2025 pursuant to Rule 1.1 of the Commission's Rules of Practice and Procedure (Rules) to 1) accept its amended DUPR and KLT Dataset associated with the Public and Confidential Versions of SCE's 2025 GNA/DUPR; (2) withdraw from the record and remove from the

Commission's files the August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR; and (3) file in place of the withdrawn August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR, with a deemed effective filing date of August 15, 2025, the amended Public and Confidential Versions of SCE's 2025 GNA/DUPR.

SCE asserts in its October 20, 2025 Motion that subsequent to filing the GNA/DUPR, SCE identified data in the Confidential and Public Versions of the DUPR that requires redaction or removal due to confidentiality concerns. SCE also asserts in its Motion that subsequent to filing the GNA/DUPR, SCE identified missing data in the KLT Dataset.

Upon review of SCE's October 20, 2025 Motion, I find SCE's request to accept the amended DUPR and KLT Dataset associated with the Public and Confidential Versions of SCE's 2025 GNA/DUPR, withdraw from the record and remove from the Commission's files the August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR, and file in place of the withdrawn August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR the amended Public and Confidential Versions of SCE's 2025 GNA/DUPR, with a deemed effective filing date of August 15, 2025, to be reasonable, in light of the confidential and data completeness concerns raised by SCE.

IT IS RULED that:

1. The October 20, 2025 Motion of SCE requesting that the Commission accept the amended DUPR and KLT Dataset associated with the Public and Confidential Versions of SCE's 2025 GNA and DUPR, accept DUPR withdrawal from the record and removal from the Commission's files of the August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR, and replace the August 15, 2025 Public and Confidential Versions of SCE's 2025 GNA/DUPR

with the amended Public and Confidential Versions of SCE's 2025 GNA/DUPR, with a deemed effective filing date of August 15, 2025, is granted.
