In the Matter of the Application of CALIFORNIA WATER SERVICE COMPANY (U60W), a California corporation, for an order:

- (1) Authorizing it to increase rates for water service by \$140,558,101 or 17.1% in test year 2026;
- (2) Authorizing it to increase rates on January 1, 2027, by \$74,162,564 or 7.7%;
- (3) Authorizing it to increase rates on January 1, 2028, by \$83,574,190 or 8.1% in accordance with the Rate Case Plan; and
- (4) Adopting other related rulings and relief necessary to implement the Commissions ratemaking policies.
