ADMINISTRATIVE LAW JUDGE'S RULING SETTING REMOTE PREHEARING CONFERENCE

This ruling sets a remote prehearing conference (PHC) for Thursday, December 11, 2025, starting at 10:00 a.m. The purpose of this PHC is to determine the parties, the parties' positions, the proceeding's scope and schedule, and any other procedural matters related to the Application.

1. Summary

On August 14, 2025, the Commission opened this Order Instituting Rulemaking (OIR) to consider revisions to the California Teleconnect Fund (CTF) program. The OIR provided a proceeding schedule with a staff proposal for additional information and analysis regarding the proposed changes to the CTF program.

By September 22, 2025, opening comments on the OIR were filed by the California Broadband & Video Association (CalBroadband), California Department of Education (CDE), California Association of Nonprofits (CalNonprofits), Corporation for Education Network Initiatives in California (CENIC), Los Angeles County Office of Education (LACOE), Pacific Bell Telephone Company D/B/A AT&T California (U 1001 C) and AT&T Enterprises, LLC (U 5002 C) (AT&T), Public Advocates Office at the California

Public Utilities Commission (Cal Advocates), and jointly by The Utility Reform Network (TURN) and Center For Accessible Technology (CforAT).

On October 7, 2025, reply comments on the OIR were filed by AT&T, CalBroadband, CENIC, LACOE, and TURN/CforAT.
