Dates to Move Exhibits into the Record

Parties in A.25-03-009,

This Email Ruling cancels evidentiary hearings in this proceeding that are currently set for December 1-5, 2025.

On November 21, 2025, Southern California Edison (SCE), The Utility Reform Network, and the Public Advocates Office filed and served a Joint Motion to waive evidentiary hearings. This Ruling grants the Joint Motion and cancels evidentiary hearings.

Additionally, this Ruling directs parties to meet and confer to prepare a list of exhibits that parties agree should be entered into the record (List of Uncontested Exhibit). By December 5, 2025, SCE, on behalf of the parties, shall submit a motion to enter the List of Uncontested Exhibits into the record. Also by that date, parties shall submit motions to enter all other exhibits not on the List of Uncontested Exhibits into the record.

IT IS RULED that:

- 1) The evidentiary hearings on December 1-5, 2025 are cancelled.
- 2) By December 5, 2025, SCE shall, on behalf of the parties, file and serve a motion to enter the List of Uncontested Exhibits into the evidentiary record.
- 3) By December 5, 2025, parties shall file and serve their motions to enter any other exhibits not on the List of Uncontested Exhibits into the evidentiary record.

The Docket Office Shall Formally File this Ruling.
