**ADMINISTRATIVE LAW JUDGE'S RULING GRANTING ORAL MOTIONS TO
ADMIT TESTIMONIES AND EXHIBITS INTO THE EVIDENTIARY RECORD
AND REMOVING EVIDENTIARY HEARINGS FROM THE PROCEEDING
SCHEDULE**

At the status conference that was noticed and held on November 21, 2025, at 9:00 a.m., LS Power Grid California, LLC (LSPGC), Pacific Gas and Electric Company (PG&E), the California Independent System Operator Corporation (CAISO), and the Santa Clara Valley Open Space Authority (OSA) made oral motions to admit testimonies into the evidentiary record. LSPGC, PG&E, CAISO, and OSA also stated that they did not see a need for an evidentiary hearing.

1. Granting Oral Motions to Move Testimony and Attachments into Evidentiary Record

I grant LSPGC, PG&E, CAISO, and OSA's oral motions to move the exhibits marked and identified as LSPGC-01, PGE-01, CAISO-01, and OSA-01 into the evidentiary record, contingent on no party objecting to the admission of these exhibits. Parties may object to the admission of these exhibits by filing and serving a response to this ruling by December 5, 2025. If no party files and serves an objection by December 5, 2025, exhibits LSPGC-01, PGE-01, CAISO-01, and OSA-01 shall be formally admitted into the administrative record.

2. Taking Evidentiary Hearings Off Calendar

The *Assigned Commissioner's First Amended Scoping Memo and Ruling and Order to Service Testimony* filed on September 23, 2025 (Scoping Memo), set evidentiary hearings for this proceeding on December 9 and 10, 2025. The Scoping Memo permits the Administrative Law Judge to modify the proceeding schedule to promote the efficient and fair resolution of the Application.

Given that LSPGC, PG&E, CAISO, and OSA do not see a need for the currently scheduled evidentiary hearings, I find that removing them from the calendar will promote the efficient and fair resolution of this Application. The scheduled evidentiary hearings shall be removed from the proceeding's schedule.

IT IS RULED that:

1. LSPGC, PG&E, CAISO, and OSA's oral motions to move exhibits marked and identified as LSPGC-01, PGE-01, CAISO-01, and OSA-01 into the evidentiary record are granted, contingent on no party objecting to the admission of these

exhibits. Parties may object to the admission of these exhibits by filing and serving a response to this ruling by December 5, 2025. If no party files and serves an objection by December 5, 2025, exhibits LSPGC-01, PGE-01, CAISO-01, and OSA-01 shall be formally admitted into the administrative record.

2. Evidentiary hearings scheduled for December 9 and 10, 2025, are removed from the proceeding's schedule.
