Dear Administrative Law Judge Ormond,

Pursuant to Rule 11.6, Charter Communications, Inc., Charter Communications Holding, LLC, and Cox Enterprises, Inc. (collectively, the "Joint Applicants") respectfully request an extension of time to respond to the November 17, 2025 *Administrative Law Judge's Third Ruling Directing Filing of Additional information Within 10 Days* ("Ruling").

Specifically, Joint Applicants request an extension of **eight business days** to file a response to the Ruling, i.e., from **December 1, 2025**, to **December 10, 2025**.

The Joint Applicants have already contacted the Communications Division to set the meet-and confer to discuss the process for submitting the requested documents. We are awaiting a proposed meeting time. To the extent Applicants and Communications Division determine the appropriate method of production, the Joint Applicants will provide responsive information prior to the extended deadline where feasible.

The requested extension is necessary due to the upcoming holiday week during which many personnel will either be out of office for some or all of the holiday week, coupled with the range of information being requested in Questions 1-3, as well as ensuring Communications Division has time to meet with Joint Applicants prior to the deadline. The additional time will enable Joint Applicants to assemble responses, as well as coordinate with the Communications Division regarding the mechanics of document production for the other information.

Because both the Ruling and this request apply solely to the Joint Applicants, no other parties are affected by this request.
