Subject: A.25-11-006: ALJ Ruling Identifying Deadlines for Protests/Responses, and PG&E's Reply to Protests/Responses

To the Service List of A.25-11-006:

This e-mail ruling identifies the deadlines for the protest and response period for Pacific Gas and Electric Company's (PG&E) Application (A.)25-11-006 for Approval of its 2027 Gas Cost Allocation and Rate Design Proposals for its Gas Distribution, Transmission, and Storage System, and for PG&E's response to those protests or responses.

PG&E filed A.25-11-006 on November 21, 2025, which would require protests and responses to its application to be filed no later than December 21, 2025.

The 30-day period for protests and responses to A.25-11-006, as filed on November 21, 2025, would fall within the period of the end-of-year holidays. Pursuant to the Commission's Rules Practice and Procedure Rule 2.6(a) the 30-day period for protests and responses can be modified by rule, decision, or General Order.

Therefore, IT IS RULED:

1. Protests or responses to A.25-11-006 are due January 7, 2026.
2. PG&E's reply to the protests and responses to A.25-11-006 is due January 20, 2026.
3. The remainder of the procedural schedule will be determined in future rulings.

The Docket Office shall formally file this e-mail ruling.
