# ADMINISTRATIVE LAW JUDGE'S RULING SETTING PREHEARING CONFERENCE AND DIRECTING PARTIES TO MEET AND CONFER AND TO FILE A JOINT PREHEARING CONFERENCE STATEMENT ^

This ruling sets a Webex prehearing conference (PHC) for January 30, 2026, at 10:00 a.m. and directs the parties to file a joint prehearing conference statement.

### 1. Setting of Prehearing Conference

A PHC is called to determine the parties, confirm the service list, determine the positions of the parties, discuss the schedule and scope of issues, and determine any additional matters relevant to this proceeding.

Parties and any interested persons shall appear virtually via Webex by using the following information:

Parties are directed to adhere to the following ground rules during the Webex Status Conference:

- Mute your Webex or phone when not speaking;
- Speak only when addressed by the Administrative Law Judge;
- State your name each and every time before you speak;
- Speak slowly and clearly;

- Do not use a speaker phone when speaking; and
- Do not interrupt or speak over one another.

Rules of Practice and Procedure Rule 1.9(f) states it is the responsibility of each person or entity on the official service list to ensure that its designated person for service, mailing address and/or email address shown on the official service list are current and accurate. A person may change its mailing address or e-mail address for e-service or its designation of a person for service by sending a written notice to the Process Office. Parties who wish to make changes or additions to the service list should complete the "Addition/Change of Official Service List" form (found on the CPUC website) and send to both process\_office@cpuc.ca.gov and reporting@cpuc.ca.gov prior to the prehearing.

Transcripts will be filed on the docket within eight weeks of the hearing. Parties desiring expedited transcripts should advise the Chief Hearing Reporter via e-mail at reporting@cpuc.ca.gov, no later than three days prior to the hearing.

#### 2. Joint Prehearing Conference Statement

To aid in the discussion this ruling directs the parties to meet and confer and to prepare a Joint PHC Statement. The parties shall file their Joint PHC Statement with the Commission's Docket Office and serve it on the Official Service list by 3:00 p.m. on January 27, 2026. Parties shall submit a copy to ALJ Moore in pdf and in Word by e-mail addressed to <a href="mailto:Theresa.Moore@cpuc.ca.gov">Theresa.Moore@cpuc.ca.gov</a>.

- 1. <u>Speakers</u>: Identify and provide the name, phone number and email address of individuals intending to speak at the PHC, and, in the case of multiple representatives for the same party, indicate who is designated as the primary party representative.
- 2. <u>Issues</u>: Identification of the specific factual and legal issues that the Commission needs to decide in this case.
  - a. Provide a joint stipulation of facts.

- b. Identify what material facts are in dispute, and what legal issues are in dispute.
- 3. <u>Relief:</u> A description of the relief sought by each party.

#### 4. Settlement:

- a. Prospects for settlement, any efforts to date.
- b. Whether Alternate Dispute Resolution (ADR) conducted by a neutral Administrative Law Judge (ALJ), other than the assigned ALJ, would be helpful in resolving the disputed issues.
- 5. Motions: Any anticipated motions.
- 6. <u>Discovery</u>: Whether any discovery is needed.
- 7. <u>Hearings</u>: Whether hearings are needed.
- 8. <u>Schedule</u>: A proposed schedule for this case.
- 9. <u>Disclosure of Non-party Interested Entities or Persons</u>: Each party shall identify any other persons or entities known by the party to have an interest that could be substantially affected by the outcome of the proceeding.
- 10. Other matters that may facilitate the just, speedy and inexpensive disposition of this matter.

## 3. Discovery

Parties are advised that they should not wait for the PHC to commence any needed discovery.

#### IT IS RULED that:

- 1. The Commission sets a prehearing conference (PHC) in the above-captioned matter for January 30, 2026, at 10:00 a.m. as detailed above.
- 2. The Parties shall file and serve their Joint PHC statement, as described above, no later than 3:00 p.m. on January 27, 2026.
- 3. To the extent discovery is required, parties shall not wait for the PHC to commence discovery.
