**ADMINISTRATIVE LAW JUDGE'S RULING SETTING A MEDIATION STATUS CONFERENCE AND DIRECTING PARTIES TO FILE A JOINT MEDIATION STATEMENT**

This ruling sets a virtual Status Conference for January 29, 2026, to discuss the status of mediation and the proposed schedule going forward. The parties shall file a Joint Mediation Statement on January 23, 2026.

**1. Joint Mediation Statement**

The Joint Mediation Statement is due to be filed on January 23, 2026. The parties are directed to include an informative discussion of the progression and status of the mediation as well as the future scheduling needs of the parties and the Commission.

**2. Setting of Status Conference**

A Mediation Status Conference is scheduled for January 29, 2026 at 2:00 p.m. to determine the nature and progression of the ongoing mediation discussion, its potential for success, and future scheduling needs. The parties should be willing to discuss whether a reasonable showing of progress towards

resolution exists. For the sake of judicial efficiency if ultimately reasonable progress is not sufficiently shown the Commission will move forward to set a schedule and bring the case into submission and completion.
