Pursuant to Public Utilities Code Section 1701.3(h)(2) and Rule 8.2(c)(2)(B) of the California Public Utilities Commission (“Commission”)’s Rules of Practice and Procedure (“Rules”), Verizon Communications Inc. (“Verizon”), Frontier Communications Parent, Inc., Frontier California Inc. (U 1002 C), Citizens Telecommunications Company of California (U 1024 C), Frontier Communications of the Southwest Inc. (U 1026 C), Frontier Communications Online and Long Distance Inc. (U 7167 C), and Frontier Communications of America, Inc.
