Pursuant to Rule 4.4 of the California Public Utilities Commission ("Commission") Rules of Practice and Procedure and the Instructions to Answer issued by Acting Chief Administrative Law Judge Michelle Cook on December 4, 2025, Pacific Gas and Electric Company ("PG&E") files this Answer to the Complaint filed October 30, 2025, by Bret Foreman ("Mr. Foreman").
