TO PARTIES AND OTHERS ON THE OFFICIAL ADDRESS LIST:

During the Prehearing Conference held September 29, 2025, counsel for Charter Fiberlink indicated that he would provide additional background on R. Adam Ray, who has provided residential and commercial sales and marketing for Spectrum since 2022, and is identified as director of sales operations in Tennessee. Counsel is asked to provide confirmation of Mr. Ray's expertise applicable to Charter Fiberlink's California operations and proposed activities related to Charter Fiberlink's expansion to cover eastern Oregon, before close of business December 31, 2025.

Additionally, counsel is asked to confirm whether (and, if applicable, how) the expansion of Charter Fiberlink's service territory to cover eastern Oregon and proposed activities therein raise any issues under the Commission's Environmental and Social Justice (ESJ) Action Plan?
