To the Service List of A.25-09-014:

This email ruling corrects an editorial error in the schedule adopted in the Scoping Memo and Ruling (Scoping Memo) for Application (A.) 25-09-014, as issued on December 23, 2025.

The schedule adopted in the December 23, 2025, Scoping Memo intends to provide parties time to consult during and after the June 22, 2026, Status Conference prior to filing the Joint Case Management Statement. The date of June 10, 2026, for the service of the Joint Case Management Statement in A.25-09-014, as provided in the Scoping Memo, was an editorial error. Pursuant to Section 4 of the Scoping Memo, the adopted schedule may be modified by the

assigned Administrative Law Judge as required to promote the efficient and fair resolution of A.25-09-014.

Therefore, the date for the service of the Joint Case Management Statement in A.25-09-014 is corrected to July 10, 2026.

No other changes to the scope or schedule of A.25-09-014 are directed in this ruling.
