Subject: C.25-02-020 Email Ruling Allowing the Complainant One Final Opportunity to File an Amended Complaint No Later than December 26, 2025.

Email Ruling C.25-02-020

On November 24, 2025, I issued an email ruling granting the Complainant the opportunity to file an amended complaint. The November 24, 2025, email ruling instructed the Complainant to file the same version of the amended complaint that was served on the service list on November 3, 2025. The Complainant failed to comply with the email ruling issued on November 24, 2025. When the Complainant filed her amended complaint she included attachments that were not part of the amended complaint that was served on the service list on November 3, 2025.

The Complainant is provided with one final opportunity to file an amended complaint. Said amended complaint shall be the same version that was emailed to the service list on November 3, 2025. Said amended complaint shall not contain and attachments of be different from the amended complaint that was served on the service list on November 3, 2025.

The amended complaint shall be filed and served no later than December 26, 2025. Failure to comply with this ruling may result in the complaint being dismissed for failing to follow the instructions of the Administrative Law Judge.

SoCalGas shall file an amended answer no later than January 21, 2026. If SoCalGas wishes to file a motion to dismiss, they should indicate in their amended answer when they intend to file the motion to dismiss. Complainant's

response to SoCalGas' motion to dismiss shall be filed pursuant to the Commission Rules of Practice and Procedure.
