**MOTION OF PACIFIC GAS AND ELECTRIC COMPANY (U 39 G) TO AMEND
SB 1221 MEMORANDUM ACCOUNT TO RECORD INCREMENTAL,
VERIFIABLE COSTS OF COMPLYING WITH DECISION NO. 25-12-042**

Pursuant to Section 5.4 of Commission Decision (D.) 25-12-042, issued on December 23, 2025, Pacific Gas and Electric Company (PG&E) respectfully files this Motion to Amend its SB 1221 Memorandum Account¹ to record incremental, verifiable costs of complying with D. 25-12-042 (“D.25-12-042 Memo Account Motion.”)

To support PG&E’s D.25-12-042 Memo Account Motion, PG&E incorporates by reference Section 5.4 of D.25-12-042 as well as D.25-07-016 approving PG&E’s existing memorandum account to record certain incremental, verifiable SB 1221-related compliance and implementation costs.² For these reasons and as provided in D.25-12-042 and in the Commission’s approval to record comparable SB 1221 memorandum account costs in D.25-07-016, PG&E requests that the Commission expeditiously approve this motion filed pursuant to D.25-12-042 with an effective date the same as the date of this filing. Upon approval of this motion, PG&E proposes to file a Tier 1 advice letter to update its SB 1221 Memorandum Account to allow recording of its incremental, verifiable SB 1221-related compliance and implementation costs effective December 22, 2025.
