I write on behalf of the City of Avalon to request an uncontested 30-day extension of time, until **February 6, 2026**, for the filing of any protest or response to the Application of Avalon Freight Services LLC (VCC-91) For Authorization to Modify Rates for Its Scheduled Vessel Common Carrier Freight Service between the Port of Los Angeles, California on the one hand, and Avalon on Santa Catalina Island on the other hand, A.25-12-001.

This request is made pursuant to Rule 11.6 of the Commission's Rules of Practice and Procedure. Consistent with Rule 11.6's meet-and-confer requirement, the City has met and conferred with counsel for the Applicant, AFS, regarding this

extension request, and Applicant has agreed to stipulate to a 30-day extension. Accordingly, the request is uncontested.

Good cause exists for the requested extension due to scheduling constraints during the year-end holidays, including reduced availability of personnel and counsel. The requested extension will also allow counsel for the Applicant and the City of Avalon to continue discussions regarding the application's proposals and related issues before the City finalizes and files its response. The requested extension will not prejudice any party and will facilitate a more complete and orderly review of the application and preparation of any protest or response.
