Pursuant to Pub. Util. Code § 583, General Order (GO) 66-C, and Rule 11.4 of the Commission's Rules of Practice and Procedure, Ex Spa Holdings, LLC ("Ex Spa Holdings") and Exiant Communications LLC ("Exiant" or "the Company", together with Ex Spa Holdings, the "Applicants"), respectfully submits this motion for leave to file under seal Exhibit B of Applicant's Joint Application for Approval of a Transfer of Control of Exiant (the "Application"), which Applicants is submitting concurrently with this Motion. This Motion seeks to maintain the confidentiality of proprietary financial information contained in **Exhibit B** to the Application.

I. Justification

Exhibit B contains the unaudited balance sheet for Exiant. This information is highly confidential financial information that may reveal Exiant's capitalization. Public disclosure would be of a significant benefit to Exiant's competitors. By reviewing the information contained in Exhibit B, competitors could determine the extent of Exiant 's operations and financial structure, which could cause significant and irreparable harm to Exiant. The information in Exhibit B is kept strictly confidential and is not available publicly. Release of that information to competitors, potential competitors, or the public could cause irreparable and continuing financial and operational harm to Exiant.

Confidential treatment must be afforded for this information for as long as it would provide a basis for Exiant's competitors to gain insight into Exiant's business operations. At this time, Exiant cannot determine the exact date on which the information provided in Exhibit B of the Application could no longer be used by competitors to Exiant's detriment.

II. Conclusion

For all of the forgoing reasons, Exiant respectfully moves the Commission for an Order directing that **Exhibit B**, which contains confidential proprietary financial information, be placed under confidential seal and not be disclosed or made accessible to anyone other than the California Public Utilities Commission and its staff.
