# Notice of Suburban Water Systems' Rate Increase Request

Suburban Water Systems' General Rate Case Application to the California Public Utilities Commission (CPUC)  
A.26-01-xxx

## What is Being Requested?

Suburban Water Systems is requesting an increase in revenue of \$41,680,219 or 40.51% from January 1, 2027, through December 31, 2029, to recover its anticipated costs for this period. Suburban projects that it will need to increase rates during this period as a result of (1) declining in per-customer water sales from continued conservation, (2) increases in production cost, including the purchase of water and energy, and (3) replacement of aging water infrastructure to ensure continued compliance with applicable water quality standards for safe and reliable water service.

## How Would This Impact the Average Residential Customer?

If the request is approved, the average residential customer using 12 CCF (1 CCF = 748 gallons) per month would see a total rate increase of approximately \$32.26 per month, phased in over three years (19.41% in 2027, 8.91% in 2028, and 8.15% in 2029). The actual impact will vary based on usage and other factors.

## Additional Information

An administrative law judge will hold hearings, consider evidence, testimony, and public comments before drafting a proposed decision on this application. CPUC Commissioners will then vote on a final decision at a public meeting.
