**ADMINISTRATIVE LAW JUDGE'S RULING ENTERING
STIPULATED EXHIBITS INTO THE EVIDENTIARY RECORD**

1. Summary

This Ruling GRANTS the November 21, 2025, *Joint Motion of Southern California Edison Company (U 338-E) and Other Parties For Entry of Stipulated Exhibits and Joint Statement Regarding Material Facts*.

2. Background

Pursuant to October 2, 2025, *Administrative Law Judge's Ruling Regarding Document Only Evidence Process and Briefing Schedule*, all Parties to Application (A.) 24-00-003 were required to 1) meet and confer; 2) prepare and serve a final list of stipulated exhibits and stipulated material facts for entry into the record of this proceeding without objection; and 3) upload pre-marked final stipulated exhibits to the California Public Utilities Commission (the Commission) website's Supporting Documents system on or before November 21, 2025.

Joint Motion Of Southern California Edison Company (U 338-E) And Other Parties For Entry of Stipulated Exhibits and Joint Statement Regarding Material Facts was filed on November 21, 2025 (Joint Motion to Enter Evidence). The Joint Motion to Enter Evidence with an incorporated joint statement regarding

material facts¹ and supporting Appendix A (*Joint Exhibit List*) was timely filed by Southern California Edison Company (SCE), San Diego Gas & Electric Company (SDGE), the Alliance for Nuclear Responsibility (A4NR), the Public Advocates Office at the California Utilities Commission (CADV), and The Utility Reform Network (TURN). On December 16, 2025, a final stipulated list of public exhibits and proposed confidential exhibits was timely circulated to the A.24-12-003 service list by SCE, SDGE, A4NR, CADV, and TURN (collectively the Joint Parties). The Joint Parties also timely lodged their respective proposed exhibits with the Commission and filed a joint motion to seal portions of the record.² On January 9, 2026, with leave of Administrative Law Judge Andrea D. McGary, the Joint Parties timely circulated a *Joint Revised Final Exhibit List*.

No motions in limine or other objection to evidence have been filed.

3. RULING

Having considered the Joint Motion to Enter Evidence, good cause appearing that the motion should be granted, it is hereby Ordered as follows:

1. *Joint Motion of Southern California Edison Company (U-338E) and Other Parties For Entry of Stipulated Exhibits and Joint Statement Regarding Material Facts* filed on November 21, 2025, is GRANTED.

2. The following pre-marked Exhibits listed below and described in Appendix A (Joint Exhibit List) attached to this Ruling and fully incorporated

herein by reference, are received into evidence and shall be binding on all Parties to Application 24-12-003:

SCE: Exhibits 0001, 0002, 0003, 0003C, 0004, 0004C, 0005, 0006, 0007, 0008, 0009, 009C, 0010, and 0011C;

SDGE: Exhibits 0101, 0102, 102C, 0103, 103C, 0104, and 0105;

SCE & SDGE: Joint Exhibit 0012;

A4NR: Exhibits 0201 and 0202;

TURN: Exhibits 0300, 0301, 0302/302C, 0303/303C, 0304, 0305/305C, 0306, 0307/0307C, 0308, and 0309/0309C; and

CADV: Exhibits 0400 and 0401.

3. The *Joint Motion To Seal a Portion of the Evidentiary Record* filed in this proceeding on December 16, 2025, remains under submission, with a final ruling to be issued before or at the time of the Commission's entry of a final decision in Application 24-12-003, regarding the requested confidential treatment of Exhibits SCE-0003C, SCE-0004C, SCE-009C, SCE-0011C, SDGE-102C, SDGE-103C, TURN-302C, TURN-303C, TURN-305C, TURN-307C, and TURN-309C.

4. Any requests to modify or add to the Application 24-12-003 Evidentiary Record, after the date of issuance of this Ruling, must be made by written motion, including at a minimum, a memorandum of points and authorities and a declaration to establish good cause grounds for any relief requested.
