Subject: A.25-05-004: Email Ruling canceling Evidentiary Hearings and Setting the Remaining Procedural Schedule

To the Service List of A.25-05-004:

This email ruling cancels the Evidentiary Hearing set for January 23, 2026, and sets the schedule for the remainder of the proceeding.

On January 16, 2026, the parties to Application (A.) 25-05-004 (Southern California Gas Company, the Public Advocates Office at the California Public Utilities Commission, and the Small Business Utility Advocates, collectively, the Parties) provided the Joint Response to the Administrative Law Judge's (ALJ) Ruling dated December 31, 2025, which sought more information about the potential contested issues of fact in the instant proceeding.

The Joint Response states that the Parties did not identify any contested issues of fact that would require evidentiary hearings, and the Parties agreed to waive evidentiary hearings.

The Parties also noted they intend to file a joint motion for the admission of exhibits, with an anticipated file date of January 21, 2026.

Pursuant to the October 1, 2025, Scoping Memo and Ruling, the schedule for this proceeding may be modified by the assigned ALJ.

Therefore, IT IS RULED that the schedule for the remainder of A.25-05-004 is as follows:

1. The evidentiary hearing scheduled for January 23, 2026, is cancelled.
2. Opening Briefs are due February 16, 2026.
3. Reply Briefs are due March 2, 2026.
4. This proceeding will stand submitted upon the filing of Reply Briefs on March 2, 2026, unless the ALJ or the assigned Commission require further evidence or argument.
5. A proposed decision will be issued no later than 90 days after submission of this proceeding.

The Docket Office shall formally file this email ruling.
