**3-DAY ADVANCE NOTICE OF EX PARTE COMMUNICATION  
OF THE GREEN POWER INSTITUTE**

Pursuant to Rule 8.4 of the Commission's Rules of Practice and Procedure, in Application no. A.25-02-022, the **Application of Green Power Institute for award of intervenor compensation for substantial contributions to Resolution Numbers SPD-29, SPD-30, and SPD-31**, the Green Power Institute (GPI), the renewable energy program of the Pacific Institute for Studies in Development, Environment, and Security, provides this *3-Day Advanced Notice of Ex Parte Communication of the Green Power Institute*.

GPI hereby gives advance Notice of an Ex Parte meeting scheduled between GPI and the Office of Commissioner John Reynolds for Monday, January 26, 2026, at 11:00 am. Gregg Morris will represent GPI. Amin Younes, Advisor to the Commissioner, will represent Commissioner Reynold's office. The meeting will take place over zoom.

We will discuss the status of A.25-02-022, a request for an award of intervenor compensation by GPI. On September 24 GPI filed supplemental information in the Application in response to a data request in the proceeding's Scoping Memo. Due to a clerical error, as part of that submission we included an old and expired version of the bylaws of the Pacific Institute. On December 11 a proposed decision (PD) was issued in A.25-02-022. The PD was based on the expired bylaws that we had filed on September 24 – a material factual error. As soon as we discovered our clerical error we began to try to correct it, filing a Motion to Correct on December 15, and culminating in our January 14 Motion to Set Aside Submission for the Taking of Additional Evidence, in which we request that the record be amended and corrected. Once the record is corrected, a PD based on the factual evidence can be crafted.

We look forward to meeting and discussing Application A.25-02-022 in order to chart a path to a Decision that is just and fair to all.
