Pacific Gas and Electric Company (PG&E) hereby provides proof of compliance with Rule 3.2(e) of the California Public Utilities Commission's Rules of Practice and Procedure.

Mailing of Notice to State, County and City Officials

PG&E met the requirement specified in Rule 3.2(b) by serving notice to State, County and City officials within our service area within 20 days of the date of its application filing. PG&E mailed notice of this application to state, county and city officials within our service area, listed on the current Roster published by the Secretary of State, on December 9, 2025. (See Attachment A.)

Publication

Commission Rule 3.2(c) requires publishing notice of our application in newspapers of general circulation within our service area within 20 days of the date of the application filing. Notice of this application appeared in print in newspapers or online within our service area on or before December 11, 2025. One weekly publication (Amador Ledger) inadvertently ran the incorrect notice in print on December 5, 2025. To rectify the error, the publication immediately placed the notice online on December 8, 2025, and ran the notice in print on December 12, 2025. The notice was placed online in Plumas County on December 5, 2025, since they only have a

digital newspaper available. The notice did not appear in Lassen County where there is currently no newspaper of general circulation. (See Attachment B.)

Mailing of Bill Insert to All Customers

PG&E met the notice requirement specified in Rule 3.2(d) by mailing a bill insert describing the rate increase associated with the above-referenced application to affected customers within 45 days of the date of its application filing. Mailing of the insert was completed on January 2, 2026. (See Attachment C.)

In addition, customers who receive electronic bills from PG&E received the insert in Attachment C as part of their bill packages. Circulation of this bill insert in electronic bills began on December 2, 2025. (See Attachment D.)

**NOTICE OF PACIFIC GAS AND ELECTRIC COMPANY'S REQUEST TO CHANGE RATES FOR ITS 2027 GAS COST ALLOCATION AND RATE DESIGN PROCEEDING (CARD) APPLICATION (A.25-11-006)**

**Why am I receiving this notice?**

On November 21, 2025, Pacific Gas and Electric Company (PG&E) submitted its 2027 Gas Cost Allocation and Rate Design (CARD) application to the California Public Utilities Commission (CPUC). This application outlines how PG&E proposes to divide the costs of providing gas services, such as distribution, transmission and storage, among different customer groups. The 2027 CARD application is part of the regular regulatory process and helps determine how gas rates are structured.

**Why is PG&E requesting this rate change?**

PG&E is not requesting new costs in this application. Instead, it is proposing how to allocate costs that are included in its proposed 2027 General Rate Case, which is currently under review by the CPUC. These costs relate to maintaining and operating the gas system, including pipelines and storage facilities. The 2027 CARD application updates how these costs are divided among customer groups based on how each group uses the system. This helps ensure that rates are fair and reflect the actual cost of providing service to different types of customers.

**How could this affect my monthly gas rates?**

Bundled gas customers receive transmission, distribution and procurement services from PG&E.

Based on rates currently in effect, the bill, including the average monthly climate credit, for a typical Non-CARE bundled residential customer averaging 30 therms per month would decrease from \$81.27 to \$76.96, or -5.3%. Actual impacts will vary depending on usage. Detailed rate information will be sent directly to customers in a bill insert in December 2025.

**How does the rest of this process work?**

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt PG&E's application, modify it or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. 

Based on rates currently in effect, the bill, including the average monthly climate credit, for a typical Non-CARE bundled residential customer averaging 30 therms per month would decrease from \$81.27 to \$76.96, or -5.3%.

Actual impacts will vary depending on usage.

## How does the rest of this process work?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt PG&E's application, modify it or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.
