Parties to A.25-06-017:

This email ruling grants the request of the Liberty Utilities (Liberty) for an extension of time to serve its rebuttal testimony.

Liberty made a good faith effort to ask the other parties to agree to the extension and received an agreement to the extension from Cal Advocates. *See*, Rule 11.6. Further, Liberty stated that it would address initial and supplemental intervenor testimony in prepared rebuttal testimony served on January 23, 2026, and that the January 30, 2026, deadline for separate supplemental rebuttal testimony would no longer be necessary. Accordingly, the requested two-day extension to serve prepared rebuttal testimony is granted, and Liberty may serve its prepared rebuttal testimony before 5:00 p.m. on January 23, 2026.
