**QUARTERLY DISADVANTAGED COMMUNITY GREEN TARIFF PROGRESS
REPORT OF SAN DIEGO GAS & ELECTRIC COMPANY (U 902 E) Q4 2025**

Pursuant to Decision (“D.”) 18-06-027 (the “Decision”), and Resolution E-4999 issued June 3, 2019, (the “Resolution”), San Diego Gas & Electric Company (“SDG&E”) files this quarterly report for program activities occurring during the fourth quarter of 2025. The Decision specifies that utilities work with the Energy Division (“ED”) on reporting requirements, and that the ED may modify such requirements as necessary.¹ As the Decision did not designate specific reporting requirements, the Resolution provides standardized reporting requirements to participating investor-owned utilities that include a quarterly Disadvantaged Community Green Tariff (“DAC-GT”) Program Progress Report that specify enrollment and subscription details by program.² This filing is the quarterly report described in the Resolution.

I. REGULATORY ACTIVITY

On June 7, 2024, the Commission issued D.24-05-065, which ordered SDG&E to close both Community Solar Green Tariff (“CSGT”) and DAC-GT, ceasing all procurement activities

and offerings for bundled customers.³ In response to D.24-05-065, SDG&E filed Advice Letter (“AL”) 4522-E on September 27, 2024, which the Commission approved on October 27, 2024.⁴ SDG&E will continue to support San Diego Community Power (“SDCP”) with their DAC-GT program as ordered in D.24-05-065.

II. CONCLUSION

SDG&E requests that the Commission accept this quarterly progress report.
