**Administrative Law Judge's Ruling Directing filing of ADDITIONAL  
INFORMATION WITHIN 10 DAYS**

This ruling directs White Diamond Limousine/Humberto Bringas Trejo  
(Appellant) to file and serve a response within 10 days of the date of this ruling.

**1. Background**

On September 11, 2025, the California Consumer Protection and Enforcement  
Division (CPED) issued Citation Number T.2025-09-006 which imposed a fine on  
White Diamond Limousine (Applicant) for two violations. On October 27, 2025,  
Applicant timely appealed Citation No. T.2025-09-006, and in its Notice of  
Appeal filing made a request to Dismiss the citation on multiple grounds.  
On December 17, 2025 the Prehearing Conference (PHC) took place virtually  
with Appellant and CPED present. At the PHC Appellant again made a request  
to dismiss on multiple grounds and stated it was unable to pay the penalty.  
These requests are being treated as a Motion to Dismiss or Reduce the Fine.

**2. Discussion**

Upon review the California Public Utilities Commission (Commission)  
determines it requires additional information to review the Motion to Dismiss or  
Reduce the Fine including the following:

1. Tax returns for the last two years for White Diamond Limousine
2. Profit and Loss Statements and/or Income and Expense statements of  
White Diamond Limousine

Appellant may conceal and redact any private financial information and file the  
documents under seal. Please see [E-File a Document](#) for instructions on e-filing

and instructions on filing of paper copies per Rule 11.4 and 11.5 of the Commission's Rules of Practice and Procedure.

Applicant shall also email a clean unredacted copy to the Administrative Law Judge at [Theresa.Moore@cpuc.ca.gov](mailto:Theresa.Moore@cpuc.ca.gov) .

If there are clarifications needed regarding the required information, Appellant may email the assigned Administrative Law Judge, copying the service list.

Within 10 days of the date of this ruling, the Applicant shall provide the additional information as directed herein. Appellant's filing must be titled "Response to Administrative Law Judge Inquiry".
