**MOTION OF THE PUBLIC ADVOCATES OFFICE
TO ADMIT TESTIMONY AND DOCUMENTS INTO THE

I. INTRODUCTION

Pursuant to Rules 11.1 and 13.8 of the California Public Utilities Commission (Commission)’s Rules of Practice and Procedure, the Public Advocates Office at the California Public Utilities Commission (Cal Advocates) moves to admit its Testimony and documents into evidence, as described in Section II below.

Cal Advocates timely submits this motion in accordance with the Administrative Law Judge’s January 21, 2026 *Administrative Law Judge’s Ruling Regarding Motions for the Admission of Evidence* (Ruling),¹ which directs that motions to admit testimony and documents into the record be filed no later than January 30, 2026.
