**JOINT SETTLEMENT STATUS REPORT**

Pursuant to the August 7, 2024, Administrative Law Judge Ruling Granting Motion to Consolidate and Adopting Updated Proceeding Schedule and the November 8, 2024, Administrative Law Judge Ruling Updating Consolidating Proceeding Schedule and Ordering Briefing (the “Rulings”), Defendant Pacific Gas and Electric Company (“PG&E”) and Complainant Jeanne M. Wilson and Redbud Chapter of the California Native Plant Society (“Complainants”) (collectively, the “Parties”) hereby file this Joint Settlement Status Report.

The Rulings directed the Parties to address the following items:

*1. The status of settlement discussions.*

The Parties continue to engage in ongoing, productive settlement negotiations and continue to agree to work towards a settlement. PG&E has provided Complainants the Restoration Plan that the Commission approved in the C.23-12-020 for additional rounds of review and comment and will be providing a draft conversation easement for review and comment. Parties will provide further updates no later than March 5, 2026, as required by the Rulings.
